

## COOKIE POLICY

Last Updated: 28<sup>th</sup> November, 2025

### 1. BACKGROUND

- 1.1. This Cookie Policy (“**Cookie Policy**” or “**Policy**”) outlines JioStar India Private Limited's (“**JioStar**”, “**we**”, “**our**”, or “**us**”) practices pertaining to various cookies on our microsite, which can be accessed at <https://www.jiostar.com/starplus/shehzaadi/> (“**Microsite**”). The terms “**you**”, “**yours**”, and “**users**” across this Policy collectively refer to end users of the Microsite.
- 1.2. We use cookies on our Microsite to distinguish you from other users of the Microsite. Cookies help us improve the Microsite and provide you with a good user experience when you browse the Microsite.
- 1.3. A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer. Cookies contain information that is transferred to your computer’s hard drive and allow us to recognise you and make your visit easier and more useful when you revisit the Microsite.
- 1.4. Below, you will see a description of each cookie that we use and how it functions. In general, please read our privacy notice available at <https://cdn.jiostar.com/jiostar/wp-content/uploads/2025/12/Privacy-Notice-Shehzaadi.pdf> to understand our data collection and processing practices.

### 2. TYPES OF COOKIES

- 2.1. We use the following types of cookies:
  - (a) Essential Cookies: These cookies are sometimes called “strictly necessary” cookies and are required for the operation of our Microsite. We use these cookies to (i) log you into our Microsite; (ii) protect your security; (iii) detect and mitigate unauthorised activities that violate end-user licence agreements and terms of use; and (iv) authenticate your access to the Microsite, among other purposes.
  - (b) Performance Cookies: These cookies are used to identify how you interact with our Microsite.
  - (c) Functionality Cookies: These cookies are used to recognise you when you return to the Microsite. This enables us to personalise our content for you, greet you by name, and remember your preferences (for example, your choice of language or region).
  - (d) Targeting Cookies: These cookies record your visit to the Microsite, the pages you have visited and the links you have followed.
  - (e) Analytical Cookies: These cookies allow us to recognise and count the number of visitors and to see how visitors move around the Microsite.

- 2.2. Additionally, please note that third parties may also use cookies, over which we have no control. These third parties may include advertising networks and providers of external services like web traffic analysis services. These third-party cookies are likely to be performance cookies or targeting cookies. We do not release the information collected from our own cookies to any third parties, other than to our service providers who assist us with providing services.
- 2.3. Management of Cookies: There are many ways through which you can manage your cookies. Some ways in which you may manage cookies include:
- (a) refusing to consent to cookies on the Microsite;
  - (b) disabling the use of cookies through your browser settings; and
  - (c) using cookie management tools to disable our cookies or third-party cookies.
- 2.4. You can block cookies by activating the setting on your browser that permits you to refuse the setting of all or some cookies. However, if you use your browser settings to block all cookies (including essential cookies), you may not be able to access all or parts of our Microsite.

### **3. CHANGE IN COOKIE POLICY**

- 3.1. We may update this Policy from time to time in order to reflect, for example, changes to the cookies we use or for other operational, legal or regulatory reasons. Please revisit this Policy regularly to stay informed about our use of cookies and related technologies.
