Note: Participation in this Contest by participants who are less than 18 years of age (“Minor Participant/s”) will be deemed as participation with the prior consent and knowledge of the respective participant’s parent/legal guardian. All undertakings as provided hereunder and the Entry Form will be signed by the parent/legal guardian on behalf of each of such Minor Participant and the word You/Applicant/Participant used for the purpose of undertakings (as mentioned in this Entry Form) shall mean parent/legal guardian of such Participant. Company shall have the authority to disqualify the participants if at any point of time, it comes to the knowledge of Company that the Participant has applied or is participating without the due consent of his/her parent or legal guardian.

1. PROGRAM DESCRIPTION:

- (a) Jiostar India Private Limited (hereinafter referred to as “**Company**”) intends to produce and broadcast, an entertainment program presently / tentatively titled as “Mr. and Master Cook Season 8” (“**Program**”). This Program gives an opportunity to participants to showcase their cooking talent, as per the process / criteria determined by Company. This Program will be produced by the third-party production house (“**Producer**”) inter-alia for the purpose of telecast on Company’s channels namely “Colors TV(APAC feed)” (“**Channel**”).
- (b) The concept of the Program revolves around the idea of displaying the bond shared between a father and his child by giving them an opportunity to showcase their cooking talent together, in a unique and innovative manner and on such format as may be further developed by Company. For clarity, father and child together only can participate for the Program and no single entry will be permitted.
- (c) Participation in the Contest is absolutely free and no registration fee is charged from the participant in any manner whatsoever by the Company or any other person associated with the Contest.
- (d) The Company intends to conduct an online contest for selection for selection of participants who are a duo of father and child and would submit their best recipes for participation in the Program, and the participant Father needs to answer a question as to Why he would like to participate in the Program and cook with his Child? (“**Contest**”), participation in Contest is open for citizens residing in Singapore only (“**Territory**”). The participants shall participate as a duo of father and child (father and child participants shall be considered as one team and shall collectively be referred to as “**Applicants**” or “**Participants**” or “**You**”) wherein the eligibility criteria is for the Father is 18 (eighteen) years and above in age, as individual and for child is to be within the age group of 8 (eight) to 15 (fifteen) years. The participation (in Contest and Program) shall be governed by the terms and conditions as detailed herein and those which may be specified / communicated later.

- (e) To participate in the Program, the Participants need to fill the participation form online on Company's Website [colorstv.com/mamc8] ("**Company's Website**") and the entries for online participation shall start from 15th July 2026 from 12.am IST and end on 12th August 2026 at 11.59 pm IST. Participants shall be required to register themselves, submit their best food recipe in writing on Company's Website, and answer the question 'Why would you like to participate in the show and cook with your child. A panel of judges would then select the best 9(nine) recipes of Participants after evaluating both responses. The selected nine (9) Participants will get featured on the Program **Mr. and Master Cook Season 8** on the Channel, from nine(9) duo Participants/teams, three(3) duo Participants/team will be selected for semi- finals and then final two (2) will be selected to compete in the finals, there shall be only one winner (i.e. one duo of father and child).
- (f) For the child, all undertakings as provided hereunder and the Entry Cum Release Form for the child, will be signed by the Father/legal guardian on behalf of such Minor Participants and the word applicant/participant used for the purpose of undertakings (as mentioned in this Entry Form) shall mean parent of such Minor Participants.
- (g) The Terms and Conditions of and in relation to the participation as stated herein, is a legal and binding agreement between the Participant and Company that states the terms that govern the Participant's participation in the Contest as mentioned herein above. By submitting the participation/registration form, on Company's Website, for selection in the Program, the Participants hereby unconditionally consents, agrees and undertakes to abide, be bound by and adhere to the Terms and Conditions herein.
- (h) Indicative / tentative schedule for registration for contest, and participation in Program are as under:

(i) **Online Contest/call for entry :**

- (a) Inviting entries for participation in Contest for the Program to be hosted on the Channel tentatively from 21st September 2026 to 30th October 2026.
- (b) Participants to submit the following on the Company's Website:
- Name of the father/legal guardian of the Minor Participant.
 - Age of the Minor Participant and their father/legal guardian.
 - Contact email id of the father/legal guardian of the Participant.
 - Mobile number of the father/legal guardian of the Participant.
 - Submit a recipe of what they would like to cook together(in 200 words maximum).
 - Answer the question: Why would you like to participate in the show and cook with your child? (in 250 words maximum):
 - Accept the Terms & Conditions, [Privacy Notice](#), provided on the Website, and give consent to collect, use, and store the aforementioned details by ticking/checking the applicable box. (Parental consent has to be sought and participation is required to be under parental guidance for the minor participants, wherever applicable.)
- (c) Date for the shooting of the show will be communicated to the selected Participants, i.e., fathers and kids must be available for shoot on tentatively 22nd August 2026 and 23rd August 2026, or as maybe communicated by the production partner/Company. The dates will be informed to them by the production partner/Company on their email-id/mobile number on or before 20th August 2026.
- (d) A panel of judges will shortlist nine(9) Participants to participate in the Program, by tentatively by 14th August 2026,11:59 p.m., IST, only when the Participants has complied with instructions pertaining to Contest and based on the submissions from

the Participants who have submitted their recipes, answered the question on why would the father like to participate in the Program, and cook with his child. In case of any dispute or difference in respect of above, decision of the Company shall be final and binding on all parties/persons.

(ii) **Participation in the Program:**

There will be 3(three) elimination episodes which will be shot for maximum 2(two) days tentatively on 22nd August 2026 and/or 23rd August 2026 (12: 00 a.m. to 11:59 p.m. IST).

(A) Elimination Round (1-3 episodes):

- i) The nine(9) shortlisted Participants will be given an opportunity to get featured and showcase their cooking talent on the Program which is to be aired on Channel.
- ii) The nine(9) shortlisted Participants will be competing against each other in the Program in accordance with the terms & conditions and instructions provided by the Company from time to time.
- iii) Out of the nine(9) shortlisted Participants only three (3) Participants will be selected to progress to the semi-final round of the Program.

(B) Semi-final Round (1 episode):

- i. Selected three (3) Participants will further compete against each other in accordance with the instructions and guidelines communicated by Company from time to time.
- ii. In this round, basis chef's/judges choice of dish/dishes, Participants will be given a recipe/recipes / dish / dishes to prepare within given time frame.
- iii. Basis the recipe/recipes / dish / dishes cooked and as decided by the chef/judges, certain Participant(s) will be eliminated in this round and the remaining will progress to the final round
- iv. Out of the three(3) participants two (2) Participants will proceed to the final round.

(C) Final round(1 episode):

- i. From the two (2) shortlisted finalist Participants, there shall be only one (1) duo of father and child who shall be the winners.
- ii. Finalist Participants will have to prepare the recipe/recipes / dish / dishes at the location, in given time frame and chef/judge will taste and decide the final winner (**'Winner'**).

Participants acknowledge and agree that decision of the chef/judge shall be final and binding. In case, if Participants are selected as Winner, Participants will get a certificate and/or a trophy as may be decided communicated by Company (**"Prize"**).

2. Company intends to video shoot the stages of the Contest specified in clause 1(g) for the purposes of making Program. The Program is presently intended to be aired on the Channel in the Territory (and in future may be aired on such other channel(s) and/or platform(s) within or outside Territory (excluding India) as Company may deem fit and proper.

3. **RULES OF THE CONTEST:**

- (a) Contest Date: For Participants submitting entries online on Company's Website shall start from 15th July 2026 from 12.am IST and end on 12th August 2026 at 11.59 pm IST.
- (b) Contest Period, and stages / timelines contemplated in clause above, may be extended and/or modified at the sole discretion of Company and the same shall be communicated to the Minor Participant's legal guardian/parent and any such modification shall apply to all the Participants, and the Participants shall be bound by the amended / modified terms and conditions.
- (c) Each Participant's legal guardian/parent shall have in his/her possession any or all of the valid and subsisting legal documents as mentioned below to prove the age of the Minor Participant and shall also provide necessary documents (as listed below) as proof of Name/address/nationality/citizenship of the Minor Participant:
 - i. Government issued identity proof.
 - ii. Birth certificate.
 - iii. Passport;
 - iv. any other document as may be required by the Organiser from time to time.
- (d) Minor Participant's participation shall only be considered upon Participants submission of true, correct and appropriate details as required by the Company.

4. GENERAL RULES FOR PARTICIPATION IN THE CONTEST:

(a) Eligibility Criteria:

- i. Contest is open to all legal and valid persons of Singapore citizens, residing in the Territory of Singapore, provided they participate as a duo of father and his child wherein the child's age fall within the age group of 8 (eight) to 15(Fifteen) years at the Contest Start Date.
- ii. There can be multiple entries in case the father wants to register with more than one child.
- iii. Participation in Contest is purely voluntary.
- iv. There is no participation fee.
- v. Notwithstanding the foregoing, the Contest is not open to employees of the Company, the Producer and its group & affiliated companies, subsidiaries, advertising promotional agencies, or any person associated with the organization of the Contest, their respective immediate families, or anyone with whom any of those persons are domiciled.

(b) Documentation and Proofs:

- (i) You confirm that You are resident or citizen of Singapore residing in the Territory of Singapore where the feed of the Channel is available and You shall submit, at Company's request valid (i) government issued identity proof (viz. Driving license; etc.), including valid proofs of age, nationality / citizenship (i.e. birth certificate and/or valid passport etc.); (ii) residence proof; (iii) any other document as may be required for participation in the Program, in consonance with the laws of India and/or any other documents as may be required by Company from time to time. You hereby represent and undertake that all personal details and/or information given by You in the form as submitted are true, accurate, complete and in no way misleading or incorrect. Further that, Company shall have the sole and unfettered right/authority (at its discretion) to disqualify any Participant from the Contest (at any point) if the Participant fails to comply with any of the terms and conditions stated herein. Additionally, You shall also sign and submit all such necessary documents/ release letters/ declaration letters/

no objection letters/certificates/ agreements etc., as required by Company and/or the Producer and/or the Company and/or its authorized representatives from time to time, in relation to the Contest, subsequent audition and/or for participating in the Program (if selected) and/or otherwise either with Company directly or any other party, as Company may require at any time.

- (ii) By submitting the information, through documents and /or otherwise, You hereby waive all privacy rights and/or any other rights including but not limited to proprietary rights, copyrights, etc. and/or any privacy expectations that You may have with respect to the use of the information furnished by You in any manner. Company may use and/or share the information with any third party for sending out commercial information and/or for other commercial, publicity or promotional purposes and You shall not raise any objection against the same.

(c) **Content Recording:**

- (i) All images, videos, audio visual recordings, audio / video clips, performance executed (including audio and video), musical recordings (audio and video), content, materials, audio / video clips, bytes, photograph(s), material (written or type or scanned), etc. provided / uploaded / submitted by the Participants ('Content') shall upon creation /submission become the property of Company and accordingly all intellectual property rights including copyrights in the Content shall vest with Company and Company shall have unfettered exploitation rights in and to the Content, through any and all modes and medium of exploitation, throughout the world in perpetuity.
- (ii) You expressly agree to your subsequent audition and participation at any stage including in the Program (if selected) being recorded and telecast as a part of the Program and/or for promotion of the Program and/or on a stand-alone basis, as required by Company ("Recording"). You hereby grant to the Channel and Company/its affiliates/group companies etc., the unfettered right to exploit exclusively and in perpetuity, throughout the universe, the Content and /or Recording, and its derivatives thereof and/ or any part thereof, through any and all means including but not limited to the right to use Your and Your Parent /Legal Guardian's name, photographs, likeness, voice, audio – visual / videos, photographs, Videos, audition videos, Content, Recording, etc. provided/submitted by You to Company and/or recorded by Company / Producer during the Contest/ subsequent auditions /Program through all media including without limitation television, radio, print, mobile, internet and/or any other such media, technology in existence, whether now known or devised in the future, from time to time, for unlimited transmission in perpetuity for entire world, as Company, may deem fit. Company shall not be obliged to exploit the Content /Recording (if made), into the final version of the Program. You agree that on submission/creation of the Content, all intellectual property rights including copyrights in the Content/Recording shall vest with Company and shall be available to Company for exploitation throughout the world in perpetuity. You hereby agree that Company shall have complete, unfettered and exclusive exploitation rights in and to the Content /Recording and have all the rights to exploit, edit, integrate other content with Content/Recording, distribute, exhibit, sell, transfer, license, sub-license, monetize and exploit the Content/Recording on various platforms and through various format, modes, media including but not limited to satellite, internet, digital, cable, wireless networks (Wireless LANs, WIFI, Broadband) WAP, imode any other modes of wired or wireless distribution or exploitation via radio frequencies etc. whether circuit switched or packet switched. These shall include linear transmission or re- transmission of Content /Recording via terrestrial, satellite television, MMDS,SMATV, DTH, IPTV, HITS, SSL, XDSL, DBS, cable television, mobile technologies, internet etc. streaming through internet / broadband / IPTV/ WAP/ iMode / other Mobile Technologies, digital TV (including DBV-H, DBV-T etc.), all forms of

on demand (SVOD, TVOD, AVOD, NVOD, PPV etc.) whether free or pay & shall include Free TV & Pay TV and shall also include all forms of non-linear transmission/exploitation including through web, internet, IPTV, mobile, applications, etc. Interactive multimedia, clips, Home Video Rental & Sell Through (including DVD, Compact Disc, Laser Disc, Blue Ray Discs, Video Compact Disc, Video Cassette, Videograms, embodying in any manner in any storage medium, VHS and such other rights), Download to Own, Download to Rent, commercial video, Internet multimedia, communication to public within aircrafts, Railways, Ships, boats, vessels, surface transport and hotel and commercial establishment rights and also include modes, media and formats of exploitation: (i) in existence now, (ii) in existence now but not in commercial use on the date of execution hereof, and (iii) as may be developed in future.

(iii) You, do not and shall not have any right to receive or claim any remuneration / compensation, fees at any time whatsoever, towards the usage / exploitation of the Content /Recording by Company and /or any party authorized by Company and further You hereby irrevocably grant and assign to Company, free and clear of any and all claims, all of the rights and interests in such Content/Recording exclusively and in perpetuity, throughout the world, and in all media, now or later known or devised including in commercial use.

(d) **Rules:**

(i) In the Contest of large number of registrations, participation, the opportunity to be considered for Contest, subsequent auditions may be strictly on submission of the application on Company's Website on the first come first basis till closure of the closing hours of Contest Period. You acknowledge, agree and undertake to abide at all times by all the rules, regulations, terms and conditions for this Contest as laid down herein and as determined from time to time by Company (the "**Rules**"). You agree and acknowledge that the Rules, may be changed at any time by Company including but not limited to modifying and/or varying and/or cancelling (in part of whole and/or in respect of one of more participants and/or in respect of one or more elements) the Contest and/or Audition and/or the Program and/or introducing new rounds / levels and/or changing the format of the Contest and/or the Program and you will be bound by such altered / changed /new Rules/new terms and conditions. You shall be responsible to make yourself aware about the altered / modified Rules / term and conditions and shall continue to be bound by the same and Company's decisions shall be final in matters concerning the same. Apart from this Company may at its discretion provide a chance for entry to the Contest for unregistered people also including but not limited to foreign national/s provided all the terms and conditions are duly complied with. You will not raise any claim or dispute due to such change and nor shall Company be liable to bring the same to your notice or attention. In case you are selected for the subsequent audition/contest/call for participation online on Company's Website, You agree to maintain the decorum of the Contest/Program venue and fill the requisite audition form/application form as required by the Producer and/or the Company and the terms and conditions contained herein and such additional audition/contest/call for participation form / application form shall govern your participation in the subsequent rounds of Contest and the Program (if selected). Further the instructions of the Company shall be adhered to strictly. Any Participant who acts in contravention to the instructions of Company or is found creating nuisance either to Company or the other Participants shall immediately be disqualified from participating in the subsequent audition / venue audition. You agree that only the final shortlisted Participants will be contacted directly by Company's representatives for every subsequent round of audition and selection in the Program and Company shall not entertain any correspondence by any Participant/person /party in this matter at any time. You shall comply with all the

applicable laws of India and /or any other applicable laws, rules and regulations in relation to Your act / participation / performance in the Contest and/or the Program and shall solely be responsible for the same at all times.

(e) **Other Terms:**

- (i) Notwithstanding anything to the contrary contained herein, You acknowledge that Company is dependent on third party/ies to make gratification / prize(s) available to Participant(s) and Winner, and that Company shall be within its rights to replace / substitute the Prize with any other award / prize (including merchandize) selected by the Company in its sole discretion in case the Company is unable to make available specified gratification / prizes.
- (ii) You hereby confirm that You are medically and physically fit and that You do not have any medical / physical / emotional condition (including heart ailment, blood pressure, final stages of pregnancy and/or psychological, anxiety, hypertension, depression or any other medical problems of any kind whatsoever, etc.) which can jeopardize Your eligibility for participation in the Program (if selected).
- (iii) If for any reason the Company is not able to carry out the registration as planned due to any activity of the Participant(s) (including Participants not providing complete details as required by the Company and/ or not abiding by the rules of the Contest Venue as required) , Company reserves the right, at its sole discretion, to disqualify any Participant who may be responsible or who tampers with the entry process, and to cancel, modify or terminate the entry. Further, Company reserves the right to take legal action against such Participant/person /party who has committed a breach under any laws as may be applicable from time to time and Company shall be entitled to such remedies in law as applicable.
- (iv) Company shall not be held responsible in case of loss of Participant's data.
- (v) Company shall not be responsible for any delay in receipt or non-receipt or incomplete entry details / other details of the Participant. Further, Company shall not be responsible and/or liable in any manner whatsoever in case the Participants are unable to register their entry and participate in the Program due to any failure on the Venue/ Company's Website / on part of the facility provider, etc. Shortlisted entries, as selected by Company shall only be intimated as per the contact details provided in the form by the Participants. Company does not accept any responsibility for any incorrect and/or incomplete entry / contact details provided and/or delay in receipt of entry / contact details and/or non-receipt of entry / contact details.
- (vi) You hereby represent that You are not under any exclusive contracts with any other third party/ agency or not under any kind of disqualification under any law to enter into an agreement with Company (as may be required) as the case may be and/or to participate in the Program (if selected).
- (vii) Company reserves the right to disqualify You immediately from the Contest, and/or from participating in Program in its sole discretion (including if you have supplied untruthful, inaccurate or misleading details and/or information, of any nature, have failed to abide by the Rules and/or are in breach of the terms hereof).
- (viii) You agree and accept that You shall not appear or participate in any other shows, programs and/or serials and/or make any public performances during the telecast of the Program, without the prior written permission of Company, if You are selected for the Program. You agree that in the Contest of breach of any undertakings herein, Company

shall be entitled to pursue such legal action as it may deem fit and necessary to mitigate any harm and loss which may be caused to it.

- (ix) In the Contest your entry is selected by Company, on terms stated herein then You shall be contacted to attend the Contest/ Audition / subsequent rounds of the Program. Further, You agree to make yourself available for subsequent rounds of the Program as per the schedule intimated by the Company.
- (x) Further, Company will inform You necessary ingredients required to prepare the dish for the final round only and the cost of such ingredients shall be solely borne by You. You shall be responsible to carry these ingredients while coming for the Program. In the Contest, if You fail, to bring all or any of the ingredient as communicated by Company You shall be disqualified.
- (xi) Unless specifically agreed by the Company in writing, Company shall not bear any expense relating to Your travel, local transportation, accommodation etc. and You shall be responsible for making your own arrangements, at your own cost and expense. Further, any and all direct, indirect, consequential, incidental expenses including but not limited to costumes, make-up, insurance (if applicable), other personal expenses and/or any other expenses of any nature, shall be borne solely by You for Yourself and Your companion (if any), and no monies will be reimbursed to You nor can any monies be claimed by You from the Company at any time.
- (xii) You shall not, without Company's prior written consent, disclose/ publicize in any manner including on social networks /social media platforms and/or any other platform nor discuss with any person/party, including without limitation the press, about any information relating to the Program, Your participation/appearance, the production team and/or any other participants in the Program or any other information which may come to Your knowledge (including without limitation in relation to Company or any of its employees, consultants or vendors), etc, and You shall maintain strict confidentiality in this matter at all times and in Contest of Your failure to comply with the confidentiality obligations, Company may/shall, at its option take legal action against You, as it may deem fit.
- (xiii) You hereby represent and warrant that You have not been accused or convicted or are otherwise involved in any offence and/or are not under inquiry or trial by the police or judiciary and that there are no criminal/civil actions pending (actual or threatened) against You currently, of whatsoever nature, and/or served against You and that You have no other disability which would affect Your participation in the Program (if selected).
- (xiv) You hereby agree and acknowledge that Company shall neither be responsible or liable for any loss, injury, mental/psychological problem /issues like anxiety, depression, stress, mishap, injury, accident, physical harm of any nature, death, any other unfortunate incident, etc., caused to You.
- (xv) You shall ensure that Your acts in Contest and/or in subsequent rounds of Program, if any, shall in no manner infringe any rights including the copyright of a third person/party. In the event of any violation to the aforementioned, You shall be disqualified immediately, without any prior notice of the same to You. You shall solely be liable for any and all action (criminal/civil) arising therefrom and shall also be liable to indemnify Company, its affiliates/group companies/employees, the Producer, agents, representatives, etc., for any loss, claim, dispute, disruption, demands, actions, liability, damage caused to Company. You specifically agree not to file in person/through any family member and/or any third party any applications, criminal

and/or civil proceedings in any courts or forum in India or outside (eg., in the Territory) against Company and/or their directors, employees, officers, affiliates or subsidiaries or Producer to claim any damages or relief of any nature in any manner in connection with Program.

- (xvi) Company shall not be liable for any loss of earnings, loss of opportunity, employment and/or otherwise caused to You or any other person, even if such loss arises as a result of You participating in the Program (if selected).
- (xvii) You hereby agree and undertake that You shall not accept or undertake to accept / give or undertake to give, either directly or indirectly, any gifts, commission or other favor, of any kind whatsoever, to facilitate your selection or participation in the Program. It is hereby reiterated that Company does not charge any money / participation fee for the Program hence, You are requested not to entertain any calls or agents in this regard.
- (xviii) You hereby represents, warrants and undertakes that in performing the obligations or exercising its rights etc. under this Entry Cum Release Form, You and your employees shall not pay, offer or promise to pay or authorise the payment directly or indirectly of, any monies or anything of value to any government official or employee or any political party or any candidate for political office or employee of a private party for the purpose of influencing any act or decision of the government official or employee, political party or candidate in order to obtain or retain participation and shall conduct themselves and all transactions under this Entry Cum Release Form and/or any transaction relating to the participation contemplated herein in a manner consistent with the intent and goals (to the extent applicable) of the OECD Convention on Combating Bribery of Foreign Public Officials in International Business Transaction, 37 ILM 1 of 15 February 1999, United States' Foreign Corrupt Practices Act, United Kingdom Bribery Act, 2010 and any other Indian law including Indian Penal Code, 1860 and Prevention of Corruption Act, 1988 ("Legislations"). If, Company becomes aware or has reasonable grounds to suspect that any transaction relating to the participation contemplated herein has taken place in contravention of the principles set forth in this clause or under the Legislations, Company shall be entitled forthwith, in its sole discretion, to terminate this Entry Cum Release Form with immediate effect and any and all other arrangements with You and/or your affiliates and the same shall be treated as material breach of the Entry Cum Release Form.
- (xix) Company is required to comply with certain international laws and is not permitted to engage with a person with whom dealings are prohibited under the economic sanctions administered by the United States, His Majesty's Treasury of the United Kingdom, the European Union or any of its member states, or the United Nations, whether as a result of the specific designation of that person, its ownership or control, the jurisdiction in which it is located, organized, or resident, or otherwise ("**Sanctions**"). Company has agreed to enter into this Entry Cum Release Form on the basis of the representation that neither You nor any of your affiliates, nor any of your directors, officers, or controllers, is/ are persons who are subject to any Sanctions. Further, if such Sanctions are imposed at any point of time, You warrants that You shall be responsible to inform Company immediately about the same as soon as it comes to your knowledge. The venue of the arbitration shall be Mumbai (India). The proceedings of arbitration shall be in English language.

(xxxi) The costs of arbitration proceedings shall be borne equally by the Parties during the arbitral proceedings. However, the Court or the arbitral tribunal (as the case maybe) shall have the discretion to determine as part of the award or the final order terminating the arbitral proceedings as to which Party will pay the costs.
