

TERMS & CONDITIONS

Spot the Banana Contest ("Contest")

1. This Contest is organized by JioStar India Private Limited ("**Organizer**" / "**JioStar**") and is open to all individual participants (the "**Participant(s)**") who shall as on August 24, 2025:
 - a. be between the age group of 4 (four) years to 14 (fourteen) years (both included);
 - b. have a valid proof of Indian citizenship;
 - c. be permanent residents of India;
 - d. not currently or permanently residing in the state of Andhra Pradesh, Telangana, Assam, Nagaland, Sikkim;
 - e. be viewers of the television channels "**Disney Channel**" ("**Channel(s)**");
2. This document is a legal agreement between the Participant and JioStar and shall be considered as an electronic record in terms of Information Technology Act, 2000 and rules there under as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology Act, 2000. This electronic record is generated by a computer system and does not require any physical or digital signatures.
3. Participant's participation in the Contest constitutes an agreement by Participant to follow and be bound by these Terms and Conditions without modification, and all other operating rules, policies and procedures that may be published from time to time by the Company. If a Participant does not agree to these Terms and Conditions, they are advised not to participate in the Contest. Please be advised if a Participant chooses to continue to participate in the Contest, it shall be deemed that they have accepted the Terms and Conditions. The Terms and Conditions are personal to the Participant, and are not assignable, transferable or sub-licensable by the Participant.
4. Participation by minors will be deemed as participation with the prior unconditional consent and knowledge of the Participant's parents/guardian. It is made abundantly and evidently clear that such Participants are participating in the Contest with the consent and assistance of their parents/guardians. Accordingly, the Participants shall provide all the necessary documents/proof as required by the Organizer upon its request in this regard. The validity of such proof shall be determined by Organizer at its own discretion. All the Terms and Conditions, Rules applicable on Participants/Shortlisted Participant/Winner shall deemed to also apply on the parents/guardians of such Participants/Shortlisted Participant/Winner.
5. The Contest shall commence on October 13, 2025, at 12.00 PM and shall conclude on October 20, 2025, at 11.59 PM or any other date as decided by the Organizer ("**Contest Period**"). The Organizer reserves the right to vary, postpone and/ or re-schedule the date(s) of the Contest or extend the Contest Period at its sole discretion. Any Contest Entry received after the Contest Period shall not be entertained and shall be considered ineligible for the Contest.
6. **Mode(s) of Participation:** To participate in the Contest, the Participant shall be required to do the following:
 - a) During the playout of episodes of "Munki and Trunk", which run on-air on the Channel, viewers will be asked to spot the banana on the screen and count the number of times the banana appears throughout the episode.
 - b) Participants will be required to scan the QR code at the end of the episodes of "Munki and Trunk", which run on-air on the Channel during the Contest Period. Once the Participant scans a QR code, they will be redirected to the Spot the Banana contest page hosted on the JioStar website at <https://www.jiostar.com/munki-and-trunk/> wherein the Participant will land on the online form ("**Form**").
 - c) In the Form, the Participant will be required to (i) provide details such as Participant's name, email, and city, and (ii) Read and click on the check-box provided in the Form including all the consents and thereafter click on the 'SUBMIT' button or such other button/option provided therein Form will be submitted to the Organizer's backend.
 - d) Participants have to answer the question of how many times the banana appears throughout the episode ("**Contest Entry/Contest Submission**"). Participants with the correct answers will be selected as the winner(s) as per the sole discretion of the Organizer.

By participating in the Contest, the Participant agree to be bound by any rules, regulations, guidelines or policies ("**Rules**") associated with the Contest and agree to be bound by any decisions made by the Organizer, including any interpretations of such Rules by the Organizer.

7. Specific Representations and Warranties

Each Participant represents and warrants that;

- a. his/her participation is voluntary with his/her own free will and consent and is not forced to participate in this Contest;
- b. all the personal information, detail, statement provided to the Organizer are true, correct, accurate and complete.
- c. he/she, have read and accepted these Terms and Conditions.

- d. that he/she will comply with all the Rules associated with the Contest including but not limited to the Terms & Conditions mentioned herein and such other rules and regulations set out therein which the Participant by virtue of participation in this Contest is bound by and agree to be bound by any decisions made by the Organizer, including any interpretations of such Rules by the Organizer and associated with the Prize (if applicable), and the Participant shall be liable for any breaches/violation/non-compliance.
 - e. the Contest Entry is and will be in adherence and compliance to all the, rules, terms, policy as set out herein, and as published on Contest Post, along with any additions, modifications, renewals, revisions to the same that may come into existence in the future.
 - f. the Contest Entry provided by the Participant shall not defame/offend any person, sect, cast, etc. it shall not be obscene, vulgar, defaming, denigrating women, offensive/insensitive to animals, pets and/or to any person/human (whether living or dead), artist, celebrity or children, hurting religious/moral/social/political sentiments, depicting violence, or against the morality/public policy of India or/and the internal policies of the Organizer.

 - i. that the Contest Entry(s) shall be suitable for presentation in a public forum, in sole determination of the Organizer.
 - j. Contest Entry shall not promote or advertise or tag any product(s), service(s) or brand(s).
 - k. Contest Entry(s) shall not contain content that depicts alcohol or tobacco or drugs or anything illegal. Contest Entry(s) shall not in any manner depict or encourage harm or injury to any person, party, animal.
 - l. he/she shall not without the prior written consent from the Organizer publish or disclose any information in connection with the Contest or Prize, including without limitation to any representatives of media in any form whatsoever.
8. In the event of any violation/breach to any of the aforementioned representation and warranties and any other term or condition, the Participant(s) shall at the discretion of the Organizer be disqualified from the Contest with immediate effect. The Organizer reserves the right to delete/remove any Contest Entry that violates these Terms and Conditions. By participating in the Contest, the Participant also agrees, represents and warrants that they shall solely be liable for any and all actions (criminal/civil), claims arising therefrom and shall also be liable to indemnify the Organizer, its affiliate and group companies and their respective officers directors, employees, partners of the Organizer for any loss, expense, liability, claim, dispute, disrepute, disruption caused to any of them, including attorney fees. The Organizer reserves the right to disqualify the Participants at its own discretion, if they are found to be in breach of the Terms and Conditions.
 9. The Terms and Conditions of and in relation to this Contest as stated herein, is an electronic record in terms of Information Technology Act, 2000 ("Act") and rules thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008 and as amended from time to time. This is a legal and binding agreement between the Participant and Organizer, that states the terms that govern the Participant's participation in the Contest. By making the Contest Entry, the Participant agrees to have read and understood the terms and conditions and hereby unconditionally consents, agrees and undertakes to abide, be bound by and adhere to the terms and conditions stated herein
 10. The Organizer reserves the right to disqualify the Participants immediately from the Contest if Participants have supplied untruthful, inaccurate, incorrect or misleading details and/or information, of any nature and/or have failed to abide by the Rules and/or are in breach of the terms hereof.
 11. **Selection of a Shortlisted Participant:** At any time during or after the Contest Period, as determined by the Organizer at its sole discretion, the Organizer will evaluate and shortlist Contest Entries which provided the most unique and interesting answer in the Contest Form, in the sole opinion of the Organizer. The aforementioned entry(ies) shall be referred to as Shortlisted Contest Entry. The Participants who have submitted these Shortlisted Contest Entry shall be selected for verification as Shortlisted Participants ("**Shortlisted Participants**").
 12. It is hereby clarified that in the event that the Organizer is of the opinion that none of the Contest Entry is eligible to be selected or that for a particular day of the Contest, there is no Contest Entry eligible to be selected, then the Organizer may exercise its discretion not to select any Participant as a Shortlisted Participant. The decision of the Organizer shall be final on this regard and no questions or communications shall be entertained in this regard.
 13. The Organizer may reach out to such Shortlisted Participant for verification and further verification of documents at any time after the Contest Period. Participants hereby acknowledge and agree that the decision of the Organizers in this regard particularly with respect to the timelines for conducting the verification and document verification shall be final and binding and no questions shall be raised in this regard.
 14. **Verification:** Before being considered as a Winner, the Shortlisted Participants may be contacted anytime by Organizer through telephone/email or as determined by Organizer and such contacted Shortlisted Participants shall be required to immediately provide Organizer with such information (as asked for by the Organizer (including mobile number, e-mail

address, residential address etc.), and also the following documents immediately upon such request by Organizer: a) PAN card b) Proof of identity cum permanent address proof – Aadhar card / Election card/Passport/ permanent Driver's License c) copy of NOC/consent of guardian/parent d) Birth Certificate/Identify certificate from schools such other documents as may be required by the Organizer from time to time, and any other documents pertaining to the sibling(s), in such manner as required by Organizer. It is hereby clarified that information and documents shall pertain to such Participant only and not of any other person. Organizer reserves the right to disqualify a Participant/Shortlisted Participant at any time, if he/she does not or fails to provide the documents/details within the timelines required by Organizer for any reason whatsoever. For further clarity, information and documents shall pertain to the immediate family member who is within the age group of 4 (four) years to 12 (twelve) years, on behalf of whom the Participant has participated in the Contest. For Participants above 12 (twelve) years of age and upto 14 (fourteen) years of age, information and documents shall pertain to such Participant only.

15. Upon verification of the documents submitted by the Shortlisted Participants to the satisfaction of the Organizer, Organizer shall consider such Shortlisted Participants as the winner ("**Winner**"). Subject to the terms and conditions mentioned herein, the final number of Winners shall be determined by Organizer at its sole discretion based on the quality of the participation/Contest Entry received for the Contest.
16. The Winner may be communicated of their winning by such date as determined by Organizer, by way of telephonic conversation or email or such other mode as may be determined by the Organizer at its sole discretion.
17. For sake of clarity, Shortlisted Participant will be not considered as final Winner(s) merely because he/she has been contacted by Organizer for verification or any other purpose.
18. Organizer reserves the right to disqualify a Participant/Shortlisted Participant/Winner at any time, if Organizer is of the opinion that the details and/or documents provided by the Shortlisted Participant/Winner is not to the Organizer's satisfaction. No questions or communications shall be entertained in this regard for any reason. Furthermore, the Organizer may at any time either forfeit the Prize or announce another Winner in place of the originally announced Winner if:
 - (i) the documents or details of the Shortlisted Participant/Winner is not correct in the opinion of the Organizer; or
 - (ii) documents so required are incomplete, misleading or untrue; or
 - (iii) the Winner/Shortlisted Participant and their respective guardians, parents do not have valid documents as may be required for the purpose of the Prize;
 - (iv) the Winner/Shortlisted Participant and respective guardians, do not sign the confidentiality, release letter or any other documents required, if any, by Organizer in relation to the Prize; or

Additionally, the Participant agrees to, and understands the terms and conditions set out below:
 - a. Participant's Personal Information is being collected by Organizer pursuant to the Privacy Notice, Participant Consent and these terms and conditions available at the Contest page with respect to Participant's engagement on the Contest page. The Participant hereby agrees that it is necessary for Organizer to collect the Personal Information in connection with the Participant's participation in the Contest and for the uses specified in these Terms and Conditions;
 - b. By filling in the Form and on affirmatively accepting or providing consents through consent banners, the Participant agrees to receive notifications and details of various deals each day. For unsubscribing you may read our Privacy Notice and write to us on DPO@jiostar.com;
 - c. Due to the nature of the Contest and upon receiving your affirmative consent, Organizer shall be required to:
 - i. share the Personal Information with Organizer, vendors, its service providers;
 - ii. Process the Personal Information for the Contest and other purposes in relation thereof, in various formats and media, including television, digital, social media and print for marketing and promotional activities in respect of the Contest. For example, Organizer can use Personal Information to announce winners on various formats and media such as television and digital platforms;
 - iii. For the purposes of contacting the Participant including for Participant gratifications, if any;
 - d. Organizer has informed the Participants of their rights and option to exercise the opt-out feature under the Privacy Notice;
 - e. All Personal Information provided by the Participant shall be true, correct and complete in all respects and in no circumstances, will Organizer be liable for either the authenticity of the Personal Information or any inaccuracies or deficiencies in the Participant's Personal Information;

20. The Personal Information of the Participant/Winner shall be provided by the Organizer to the extent allowed by law, to others assisting the Organizer in this regard, including its affiliates, associates, authorities, agents, sponsors, employees, prize suppliers, distributors, deliverers and service providers (as applicable).
21. If applicable, the parents/guardians of such Shortlisted Participant/Winner(s) may be required to sign the release form in the format required by the Organizer, for and on behalf of the Winner(s). Further, such Shortlisted Participant/Winner(s) shall be required to submit to the Organizer, a document evidencing the fact that his/her participation in the Contest was approved by and was subject to the prior unconditional consent and knowledge of his/her, parents/guardian.
22. **Prize:**
- a. Each Winner shall receive either a laptop or a tablet worth up to approximately INR 50,000/- (“Prize”), on such timelines as determined by Organizer at its sole discretion.
 - b. The Prize shall not be transferable/ redeemable for cash. No request shall be entertained by the Organizer in this behalf.
 - c. The Organizer shall not be responsible for the quality or deficiency etc. of the Prize and no claim or request, whatsoever, in this respect shall be entertained by the Organizer.
 - d. The Organizer shall have the right to modify the Prize (or any item/element comprising the same) without assigning any reason for the same and the Organizer shall not be held liable for the same.

The Participants hereby agree and undertake that they shall not accept or undertake to accept/give or undertake to give, either directly or indirectly, any gifts, commission or other favor, of any kind whatsoever, to facilitate their winning the Contest. Any knowledge of such an act shall lead to immediate disqualification of such Participants and the Organizer shall be entitled to take any/all actions against such Participants, as deemed fit by it.
40. The Organizer shall not be responsible for the quality or deficiency of the Prize and no claim or request, whatsoever, in this respect shall be entertained by the Organizer.
41. It is clarified that the Winner/Participant shall, in no circumstance, have any rights or claims against the Organizer.
42. The Organizer is not responsible for any errors or omissions in the Terms & Conditions contained herein. All information provided in the Contest is provided "as is" without warranty of any kind. The Organizer makes no representations and disclaims all express, implied and statutory warranties of any kind to the Participants and/or the Winner and/or any third party including, without limitation, warranties as to accuracy, timeliness, completeness, merchantability, or fitness for any particular purpose.
43. Under no circumstance, shall the Organizer and/or its parent, subsidiaries, associates, affiliates and group entities, and their respective directors, employees, officers, agents or representatives be liable to the Participants and/or the Winner or any third party for any lost profits or lost opportunities, indirect, special, consequential, incidental, or punitive damages whatsoever, even if the Organizer has been advised of the possibility of such damages. The Participants and the Winner specifically agree not to file in person/through any family member and/or any third party, any applications, criminal and/or civil proceedings in any courts or forum in India against the Organizer, its parents, subsidiaries, associates, affiliates and group entities, and their respective directors, employees, officers, agents or representatives to claim any damages or relief in connection with the Contest.
44. The Organizer may, at any time, at its discretion, suspend, cancel, postpone the Contest, change these Terms & Conditions, the Rules and/or the Prize mentioned herein, without prior notice, and the Participants/Winner acknowledge that such change shall be final, binding and irrevocable upon them.
45. The Participants/ Winner acknowledge that they will not hold the Organizer and/or any of its affiliates or agencies engaged by it with regard to this Contest liable for any loss of opportunity and/or monetary loss due to their participation in the Contest.

46. By participating in the Contest and accepting the Prize, the Participants and/or Winner waive all copyrights and any related rights. The Participant consents to the Organizer's right to click photographs, take pictures, shoot audio-visuals, tape, record, exhibit or portray them as the Winner/Participant and/or publish any Contest Entry, content submitted by them, feature them in video shoot/recording if any. 48. The invalidity or unenforceability for any reason of any part of these Terms & Conditions shall not prejudice or affect the validity or enforceability of the remaining parts and each part of these Terms & Conditions is distinct and at all times severable from the rest of the Terms & Conditions.
49. No waiver of any rights by the Organizer will be taken as a waiver of any other rights it may have. For instance, if the Organizer waives its right to object to a particular breach of these terms and conditions by a Participant/Winner, it does not prevent the Organizer from objecting to any other breaches by that Participant/Winner and/or or any other /Participant/Winner.
50. The Contest shall be subject to the exclusive jurisdiction of competent Courts at Mumbai and the law applicable shall be Indian Law. The Contest shall not be valid and no participants from any city/state may participate, if such contests and participation, is prohibited, as per applicable law in the states that they reside in/belong to.
