

“VIJAY PATTU THIRUVIZHA” | WATCH & WIN CONTEST

TERMS AND CONDITIONS

These terms and conditions (“**Terms & Conditions**”) shall be binding on all participants (each a “**Participant**” or “**You**”) who voluntarily agrees to participate in the contest “**Vijay Pattu Thiruvizha**” **WATCH & WIN CONTEST**” (“**Contest**”) which will be hosted by JioStar India Private Limited. (“**JIOSTAR/ JIOSTAR INDIA/ Company** ”) for the purpose of promotion and participant engagement during the telecast of a various television programs between (“**Programs**”) on its channel ‘Star Vijay’ (“**Channel**”). The following terms and conditions govern the entire process in relation to the Contest and shall be binding on each participant (“**Participant**”/“**You**”/“**Your**”) who voluntarily participates in the Contest hosted by JioStar India for the purpose of promotion and viewer engagement of its Channel.

To participate in the Contest, You hereby agree and understand that JioStar will have access to and collect information and data shared by the Participant, including their personal information. such as name, contact number, email ID, residential address, Aadhar Card/identity proof and/or other personal information (“**Personal Information**”). By participating in the Contest, the Participant hereby consent to the collection, receipt, storage, disclosure, processing, transfer, use, retention, sharing of the Personal Information by JioStar, its affiliates, and designated third parties in accordance with the terms of its Policy. Any information gathered through these Terms shall be subject to the terms and conditions as available at <https://cdn.jiostar.com/wp-content/uploads/tnc/1767598286-Privacy-Notice---Vijay-Pattu-Thiruvizha.pdf> (“**Website**”).

JioStar India is committed to protecting the privacy and the confidentiality of the Personal Information received. JioStar India agrees to use the Personal Information strictly for the purposes of this Contest only and not to retain the same for a period longer than 30 (thirty) days from expiry of the Contest Period. JioStar India uses commercially reasonable efforts and general industry standards to protect such information from any unauthorized access or disclosure. The Participant agrees and acknowledges that Privacy Policy shall be deemed accepted and agreed to by every Participant, by agreeing to participate in the Contest, shall govern all usage of any Personal Information (as defined in the Privacy Policy and/or any other information as detailed in the Privacy Policy and/or any information gathered by JIOSTAR under or pursuant to the Contest.

Any information gathered through these Terms and Conditions shall be subject to our Privacy Policy which is available at our Website incorporated herein by reference. Your act of participating in the Contest shall be deemed to be your absolute agreement to the Terms and Conditions, Terms of Use, Privacy Policy and User Generated Content of JioStar India as prescribed from time to time (hereinafter collectively referred to as “**Terms and Conditions**”). If You do not agree to be bound or cannot comply with any of the Terms and Conditions, please do not continue. Your failure to agree to these General or Principal Rules (as stated herein below) or the Privacy Policy or Terms of Use or User Generated Content will disqualify Your participation in the Contest. The Contest shall be governed by the Terms and Conditions and all the Participant(s) in the Contest shall unconditionally accept and agree to comply with and abide by the same. The Contest shall be governed by the Terms & Conditions and all the Participants in the Contest shall unconditionally accept and agree to comply with and abide by the same.

The Privacy Policy available at the Website shall govern all usage of any Personal Information and/or any other information as detailed in the Privacy Policy and including but not limited to the mobile phone number and/or any information in relation to Your participation in the Contest gathered under or pursuant to this Contest by JioStar India (if any).

JioStar India reserves the right to revise these Terms and Conditions at any time without prior notice to the Participant(s). The Terms and Conditions and revised terms if applicable, will be effective immediately upon uploading the same on Website unless otherwise mentioned. Your continued participation in the Contest shall be deemed acceptance of such Terms and Conditions. You acknowledge that no knowledge of the revisions made shall not be a defence in any proceeding with regard to the Contest. The decisions of JIOSTAR for all matters relating to the Contest shall be final and binding in all respects.

The Terms and Conditions of and in relation to the Contest as stated herein, are an electronic record in terms of Information Technology Act, 2000 (“**Act**”) and rules thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008. This electronic record is generated by a computer system and does not require any physical or digital signatures.

The Contest shall be governed by the Principal Rules and General Rules as stated herein below and by agreeing to participate in the Contest, Participants shall be deemed to have unconditionally accepted and agreed to comply with and abide by the same prior to participating in the Contest. If the Participant does not agree to be bound or cannot comply with any of these Terms and Conditions and/or the Policies (defined below), then the Participant should refrain from continuing with and/or participating in the Contest

I. PRINCIPAL RULES

1. JioStar shall announce the Contest via on-air promos (promos, Astons, bugs, etc.) on the Channel, digital platforms of the Channel including Facebook, X and Instagram and/or through any other medium of exploitation which shall be at the sole discretion of JIOSTAR.
2. The Contest shall be conducted on a daily basis, during the corresponding week, comprising between Monday to Saturday, commencing from Jan 6, 2026 and ending on Jan 31, 2026, between 1:30pm to 4:00pm Indian Standard Time (“**IST**”), (“**Contest Period**”) on the Channel. JIOSTAR reserves all rights to make amendments to the Contest Period or such other terms and conditions stated herein, without giving prior notice. It shall be the sole responsibility of the Participant(s) to check the Terms and Conditions applicable to the Contest on the Channel and /or the Website from time to time. JIOSTAR also reserves the right to cancel and/or postpone the Contest without any prior intimation to the Participant(s).
3. The Contest shall comprise of 5 (five) multiple choice questions based on each of the Programs telecasted on the Channel and triggered on a daily basis during the corresponding week of the Contest Period (“**Questions**”). It is hereby clarified that the Questions will be changed and refreshed on a daily basis by JioStar India during the corresponding week of the Contest Period. Each Question(s) of the Contest triggered during the Contest Period shall be strictly based on the contents of each corresponding Programs as mentioned in Schedule 1 herein being telecast on the Channel during the corresponding time slots falling within the corresponding week of the Contest Period. The total number of Questions triggered during the Contest Period shall not exceed 5(five). During the Contest Period, on a daily basis during the corresponding week, during the telecast of the Programs on the Channel the Questions will be triggered on the Channel accompanied by an aston and /or voiceover question template, which will be played 2 times during the Programs and/or commercial breaks for not

more than 25 seconds, carrying the link which will direct the Participants to details of the Contest mechanism, as deemed fit at JIOSTAR's sole discretion.

4. To participate in the Contest and to be eligible for the Prize (as defined below), the interested Participant(s) shall be required to answer the Questions triggered on the Channel on a daily basis during the corresponding week (Monday to Saturday) of Contest Period in the following manner:
 - i. answer all 5 (five) Questions *on a daily basis* by making a missed call to the unique mobile numbers/ VMN assigned to the respective answer options for the Questions (**"Answer/ Entry"**).
 - ii. Out of the Answer/ Entry received on a daily basis, a minimum of 5 Answers have to be correct. To enable the Participant to qualify further for the Prize, this is a mandatory requirement. Only Entries received during the Contest Period are valid i.e. Participants shall give a missed call to the VMN assigned to the options mentioned only during the Contest Period).
 - iii. If the Participant provides an incorrect Answer, then his/her Entry (as defined below) shall be considered incomplete, and the Participant(s) shall not be eligible for the Prize (as defined below). Answer(s)/Entry(s) received by JIOSTAR after Contest Period will not be considered and shall be deemed null and void without requirement of any further intimation by JIOSTAR. It is further clarified that missed call made by the Participant to an incorrect number or sent after the Contest Period will be deemed invalid and such Participant will be disqualified. For the purposes of this Contest, "receipt" of Answer(s) occurs when the mobile/network operator records the Answer upon the Participant(s) selecting the VMN assigned to the corresponding Answer Option through the missed call mechanism. Providing the correct Answers for the Questions during the Contest Period by the Participant(s) through missed calls to the VMA(s) assigned to the answer options shall be considered as a complete and valid entry (**"Entry"**). For the avoidance of doubt, by submitting the Entry and /or Answer(s) the Participant(s) is representing that the Entry(s) and /or Answer(s) or contents thereof are not confidential or comprise any sensitive Personal Information.
 - iv. It is clarified that each Participant shall be allowed to send only one Entry from one particular mobile number for the Question for one specific day during the Contest Period and the Participant shall not be allowed to submit /provide Answer(s)/Entries innumerable times through missed calls from the same mobile number to the unique mobile numbers assigned to the answer options for Question during the Contest Period. Answer/s Entries (i.e. missed calls) received after the Contest Period shall be considered null and void.
5. This Contest is subject to the guidelines /directions issued by TRAI and any other statutory authority from time to time.
6. It is clarified that all costs incurred by the Participant(s) to participate in the Contest shall be solely borne by the Participant(s) without any recourse to JIOSTAR.

7. In case of telecom, network failure and/or any other reason, JIOSTAR reserves the right to change the mechanism of the Contest or take such necessary steps as it may deem fit.
8. Upon the Participant(s) sending in their Entries to the Questions, the mobile number from which the Participant(s) have answered the Questions would get registered with the respective network provider.
9. It shall be deemed that the person in whose name the mobile number is registered (from which the missed call is made) shall be construed to have sent the Answer (s)/Entry(ies) for the Contest.
10. JIOSTAR and/or the Channel reserves the right to disqualify any Participant(s) from participating in the Contest without assigning any reason whatsoever. The decision of JIOSTAR and/or the Channel in this regard shall be binding upon the Participant(s).
11. During the Contest Period , at the end of the each and every corresponding daily contest period, every Participant(s) on the basis of the Participant on a daily basis having made a valid Entry i.e. submitting Answers to all Questions and submitting a minimum of 5 correct Answers to the Questions triggered during the corresponding daily period within the Contest Period, JIOSTAR shall shortlist the Entries at its discretion. Out of the shortlisted Entries, JIOSTAR will select 1 (one) winner and 1 (one) back up winners per day of the Contest Period, on randomiser basis based on the aforementioned criteria (“**Winner(s)**”). Each Winner shall be entitled to 1(one) silk / Pattu saree, the value and brand of the said gratification being determined by JIOSTAR at its sole discretion, which shall be dispatched via courier to the addresses as communicated by the Winner(s) to the representatives of JioStar within minimum 15 (fifteen) days of such announcement (“**Prize**”). It is further clarified that JIOSTAR shall at its sole discretion select the Winners based on the criterion (randomizer) mentioned herein. Failure by Winners to follow the instructions may lead to the Winner being disqualified and JioStar at its sole discretion may not award the Prize to the Winner.
12. The Winners along with their city name will be announced on a daily basis during the Contest Period, on the digital platforms of the Channel including on Facebook, X and Instagram through a branded video promotion, or as deemed fit by JIOSTAR.
13. Mere participation in the Contest does not entitle the Participant(s) to win the Prize. Only the Participant(s) having made a valid Entry(ies) and providing 5 correct Answers to the Questions on a daily basis triggered during the corresponding daily contest period of Contest Period shall be eligible to the Prize. It is further clarified that save and except the Prize, the Participant(s)/Winner shall not be entitled to any other form of gratification (monetary or otherwise).
14. JIOSTAR, through its representatives and/or agents’ shall call the Winner on the mobile from which the Entry is made by the respective Winners using their Tamil-speaking call centre team and inform him/her of winning of the Prize, within 7 (seven) days from the date of declaration of the Winners. During the call, the representatives of ThinkROI will ask the Winner to submit to JIOSTAR or their representatives, his/her photograph, scanned copies of his/her PAN card copy, ID proof, age proof which shall be any of one of the documents viz valid passport copy, pan card copy (Id proof only), driver’s license, Aadhar card, Ration card along with last two months phone bill for the mobile number registered with JIOSTAR (from

which the Participant has submitted his/her Entry in the Contest). (“**Winner’s Documents**”). The Winners shall be required to submit the Winner’s Documents to Rights Choice and/or JIOSTAR/their representatives within seven days from the date of the telephonic communication received from JIOSTAR by the Winner to the email Id provided by the representatives of JIOSTAR during the call. After receiving the Winners’ Documents, to the satisfaction of JIOSTAR and/or through its representatives and/or agents, the Winners will get an SMS (“**Winner’s SMS**”).

15. The representatives of JIOSTAR will make maximum 3 (three) attempts to contact the Winners on the mobile number from which the Entry is made by the Winners. In case, if lines are busy or phone is engaged, or mobile number is not reachable or switched off, in all the 3 (three) attempts for any reason whatsoever for a maximum period of 1 (one) month, then JIOSTAR or its representatives shall select some other Participant as a Winner via the randomizer process and call for the Prize. JIOSTAR shall not be responsible to any Winner, if the winning information sent by the representatives of JIOSTAR is not reached or received by the Winner for any reason whatsoever including but not limited to mobile network failure or any other technical or non-technical flaws because of which the Winner is unable to receive the Prize.
16. If any of the Winners fails to collect the Prize within 1 (one) month, the same shall be expired/lapsed and the Winner will not be entitled to claim the Prize thereafter. The aforesaid 1 (one) month period for collecting the Prize will not be extended at any cost.
17. In the event the said Winner fails to adhere to the instructions of JIOSTAR and/or fails to follow all the requisite steps as more particularly mentioned herein, then his/her selection shall be invalidated and JIOSTAR shall not be liable to that Winner in any manner whatsoever.
18. JIOSTAR and/or the Channel reserves the right to decide the Winners of the Contest at its sole discretion.
19. It is clarified hereby that JIOSTAR shall have a discretionary right to postpone/ cancel/change the destination of the Prize of reasons of unavoidable circumstances.
20. The Prize is non-transferrable and non-exchangeable. For the purpose of clarity, no cash equivalent or alternative prize shall be given to the Winners and the Winners cannot exchange the Prize for a gift of equivalent value. 22. The decision of JIOSTAR and/or the Channel shall be final and binding on all the Participant(s) and by participating in the Contest, it shall be construed that the Participant(s) has waived his/her right to raise any dispute against any decision made by JIOSTAR and/or the Channel.
23. By participating in the Contest, it shall be construed that the Winner has waived his/her right to raise any dispute in connection to the Contest and/or the selection procedure and/or the details of the scores and/or the Winner and/or the Prize.

24. The final selection of the Winner shall be made by JIOSTAR and shall be final and binding on the entire group of Participants and in no event shall the Participants dispute the decision made by JIOSTAR or its employees in connection to the Entry/Answer and /or the Contest. For the sake of clarity, in the event of any fault, misunderstanding or dispute concerning any part of the Contest and/or the selection process to qualify for the Contest, the decision of JIOSTAR shall be final and binding.

26. By entering the Contest, each Participant acknowledges and agrees that: (i) any and all disputes, claims and causes of action arising out of or in connection with the Contest, or any Prize awarded, shall be resolved individually, without resort to any form of class action; and (ii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred and associated with entering the Contest (if any), notwithstanding the foregoing, under no circumstances will JIOSTAR and/or JIOSTAR entities be liable for any consequential, indirect, special punitive, or incidental damages or lost profits, whether direct or indirect, arising in any way whether in contract, tort (including negligence) or otherwise.
27. JIOSTAR reserves the right to disqualify any Participant(s)/ Winner(s) from participating in the Contest if his/her conduct is found to not be in concurrence with the Terms and Conditions set out herein or as may be revised by JIOSTAR from time to time. JIOSTAR reserves the absolute right and discretion to reject any Entry/ Answer or any part thereof at any stage of the Contest, including after declaring the Winners, if JIOSTAR:
- a. receives any notice or complaint relating to the Entry/ Answer not being compliant of the Terms and Conditions including alleged to be infringing any form of rights including rights in any form of intellectual property of any third party;
 - b. determines at its sole discretion that the Entry / Answer is *inter alia*, belongs to another person and to which the Participant does not have any right to; blasphemous, indecent, immoral, abusive, offensive, against the applicable laws or libellous and/or is contrary to any law in force; is grossly harmful, harassing, defamatory, obscene, pornographic, paedophilic, libellous, invasive of another's privacy, hateful, or racially, ethnically objectionable, disparaging, relating or encouraging money laundering or gambling, or otherwise unlawful in any manner whatever; harm minors in any way; infringes any patent, trademark, copyright or other proprietary rights; violates any law for the time being in force; deceives or misleads the addressee about the origin of such messages or communicates any information which is grossly offensive or menacing in nature; impersonate another person; contains software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer resource; threatens the unity, integrity, defense, security or sovereignty of India, friendly relations with foreign states, or public order or causes incitement to the commission of any cognizable offence or prevents investigation of any offence or is insulting any other nation.
28. The decision of JIOSTAR with regard to clause 28 hereinabove, shall be final and binding upon the Participant(s)/ Winner.

29. In consideration of the participation in the Contest, Participant/ Winner hereby irrevocably, exclusively and perpetually assigns all rights, titles and interest in and to the text or any parts thereof submitted with the Entry and/or the Answer, during or pursuant to the Contest, including rights in any forms of intellectual property including but not limited to right to use, add, alter, translate, adapt any Entry made including but not limited to for use of the same on the world wide web (internet), publication, communication to the public in any other form of media for the entire world to JIOSTAR. To the extent, the above assignment is not held valid by operation of law, the Participant(s)/ Winner in consideration of participating in the Contest, hereby also grants an exclusive, perpetual, sub licensable license to JIOSTAR for use in the entire world in any media and form as JIOSTAR may deem fit, of the texts, Entry or any parts thereof submitted during the Contest to JIOSTAR including right to use, add, alter, translate, adapt any Entry made including but not limited to for use of the same on the world wide web (Internet), publications, communication to the public in any other form of media. The Participant(s)/ Winner waives any so-called moral rights in the Entry.
30. Neither JIOSTAR and/or Channel nor its employees have given a guarantee regarding the quality of the Prize and the Winner agrees not to hold JIOSTAR and/or the Channel and its employees, responsible with regards thereof.
31. By participating in the Contest, it is construed that the Participant(s)/ Winner has read and understood these Principal Rules including the General Rules stated below and has agreed to abide by the same.
32. Any and all incidental costs direct and/or indirect, in relation to the Contest, shall be borne by the Participant(s), and in no manner whatsoever shall the Channel/JIOSTAR, be responsible for the same.

II. GENERAL RULES

1. In the event of any fault, misunderstanding or dispute concerning any part of the Contest, the decision of JIOSTAR shall be final.
2. The Participant(s) should not have been previously convicted of any criminal offense or must not be a party to an arrangement or a contract that prevents them from participating in the Contest. The Employees of the JIOSTAR, employees of Right Choice and Sathya Agencies and members of their immediate family, are not eligible to participate in the Contest.
3. Participant should be a citizen and resident of Tamilnadu, India, who is physically present and located in Tamil Nadu and who is of 18 years or above as on the date of the commencement of the Contest.
4. Proof of age, if requested, of the Participant(s) must be submitted to JIOSTAR (i.e., Birth Certificate, 10th Standard graduation Certificate/ School certificate/ passport/ an affidavit signed by a magistrate and attested in such manner) as may be required by JIOSTAR to confirm the eligibility of the Participant(s). JIOSTAR also reserves the right to disqualify a Participant(s)/ Winner(s) in case a discrepancy is found to exist in the information furnished/ provided/ stated by the Participant(s)/ Winner(s) at any point of time during the Contest Period.

5. The Participant(s)/ Winner represents and undertakes to execute and produce such further documents as may be required by JIOSTAR in relation to the Contest.
6. Participant(s) agree, understand, and acknowledge that there is no prize/gratification for merely sending an Entry in the Contest.
7. Each Participant consents to the use of information submitted by the Participant(s)/ Winner including the Entry(s)/ Answer(s) for the purpose as set out in these Terms and Conditions.
8. JIOSTAR reserves the right to cancel and/ or postpone the Contest without assigning any reasons and/ or without giving any prior intimation to the Participant(s).
9. In case a Participant(s)/ Winner is found to be in non-conformance of the Terms and Conditions, Terms of Use, User Generated Content or Privacy Policy, then JIOSTAR will disqualify the Entry/ Answer received from such Participant(s)/ Winner.
10. The Terms & Conditions shall be advertised sufficiently across the Website to ensure that no Participant is misled and understands the entire participation process prior to participating in the Contest.
11. In case of any telecom and /or network failure, unclear network, disruption in the network, and /or technical failure in submitting and/ or providing the Entry/ Answer and/or for any reasons whatsoever, JIOSTAR reserves the right at its sole discretion to change the Contest mechanism for submitting the Entry/ Answer and /or cease from accepting Entry/ Answer of the Participant(s)/ Winner(s) during the Contest Period in any manner it deems fit and necessary. In addition JIOSTAR shall not be liable and /or responsible in any manner whatsoever in the event of any malfunction/fault /failure in the Contest mechanism for submitting the Entry/ Answer including without limitation system failure in the mechanism of recording missed call due to any reason whatsoever including technical disruption/phone lines being open / a default in sending out the SMS alert to the Participant(s) upon sending the Entry/ Answer / close or default / failure/ any other difficulties of such nature due to which the Participant(s) is unable to participate or record his/her Entry/ Answer/ failure to logging on automatic acceptance of missed call as stated in these Terms and Conditions and /or informed during the telecast of the Film due to technical /technological restrictions and /or due to reasons /events/incidents beyond the commercially reasonable control of JIOSTAR.

To the extent permissible in law, Participant(s) shall not in any circumstances make any claims against JIOSTAR, Channel, their employees, directors or its affiliates arising out of or relating to any and all costs, injuries, losses or damages of any kind that may be suffered, including, without limitation due to any technical faults in the network and/ or connections or directly or indirectly due to or relating to their participation or non-participation in the Contest mechanism. If the Participant(s) is found to be ineligible, or if they have not complied with these Terms and Conditions, the corresponding Entry(s) will be disqualified.
13. The Winner must at the request of JioStar submit with JIOSTAR and/or the Channel a copy of bills issued by the network operator as a proof that the mobile number is registered in the name of the Winner and such other documents that could be furnished as proof that the mobile number is registered in the Winner name.
14. The Winner agrees to maintain complete confidentiality regarding their selection for the Prize and any matter relating thereto and shall not disclose any information pertaining to the Prize

or the Contest which is disclosed to the Winner and which is not available to the public in general, to any person or media etc. without the consent of JIOSTAR. 18. JIOSTAR reserves the right to forfeit the Prize in the event it is found by JIOSTAR, or it has a reason to believe, that any information provided by the Winner including Personal Information is wrong, incorrect, fraudulent or misleading. JIOSTAR shall have the right to declare another Participant(s) (on a random basis on the criterion mentioned herein) as the Winner of the Contest, at its sole discretion and transfer the Prize to such person. Such decision of JIOSTAR shall be final and binding.
19. The Winner agrees that if due to any reason, whatsoever, beyond the control of JIOSTAR, the Prize and/or the benefit in connection thereto becomes ineffective, invalid or unavailable (e.g. cancellation/postponement of the Contest), JIOSTAR shall not be held responsible and/or liable for the same.
20. JIOSTAR makes no representation and/or warranty regarding the Prize other than those given in these Terms and Conditions and hereby expressly disclaims all other warranties, expressed or implied.
21. The Winner shall be solely responsible to avail the Prize at the time of delivery. The Winner agrees that he/she shall not hold JIOSTAR and/or its employees, responsible for delays in delivery due to shortage of stocks from the suppliers of the Prize or damage during transit or any problem in connection to the Prize.
22.
