

## PRIVACY NOTICE

At JioStar India Private Limited (formerly known as Star India Private Limited) (“**JioStar**”, “**we**”, “**us**”), we respect your privacy and are committed to protect your personal data. This Privacy Notice (“**Notice**”) explains how we collect, use, store, and protect personal data in connection with auditions (“**Auditions**”) for the program “SUPER SINGER JUNIOR - SEASON-11” (“**Program**”).

The Notice is intended to be read along with any consent request forms or banners that we may make available to you.

### 1. Personal Data Collected

We shall collect personal data about you and your children (collectively, “**Participant**”), such as:

- (a) Child’s name;
- (b) Child’s age;
- (c) Child’s performance for the audition;
- (d) Parent or legal guardian’s name;
- (e) Parent or legal guardian’s residential address;
- (f) Parent or legal guardian’s mobile number;
- (g) Parent or legal guardian’s email address.

### 2. Purpose of Collection

We shall collect and process personal data about a Participant to (a) assess, evaluate and enable your child’s participation in the Program through the Auditions; (b) issue rewards and prizes in connection with the Program if your child is declared a winner by JioStar; (c) telecast, broadcast, the Auditions and/or the Program on JioStar’s channels and/or OTT platform; or (d) comply with our obligations under applicable laws. The specific purposes of processing and the corresponding personal datasets are more specifically set out in the consent request form accompanying this Notice.

### 3. Data Security

We implement adequate security measures to protect your personal data from unauthorised access, and such security measures are in compliance with the security practices and procedures as prescribed under applicable law.

### 4. Data Retention

We will retain your personal data only for as long as necessary to fulfil the purposes outlined in Clause 2 hereinabove or as required by applicable law.

## 5. Disclosure of Personal Data

We may share your personal with our affiliates or group companies or our service providers, business partners, or any other third party for the purposes detailed in this Notice and the relevant consent request form. We may also, where required by law, disclose such personal data to any court, government agency, or authority.

## 6. Data Principal Rights

Under certain circumstances and subject to applicable law, you may have certain rights in respect of your personal data. If you wish to exercise any of the rights set out above, please write to us in the manner specified under Clause 7.
