

## TERMS AND CONDITIONS

JioStar India agrees to use the Personal Information strictly for the purposes of this Contest only and not retain the same for a period longer than 30 (thirty) days from expiry of the Contest Period. JioStar India uses commercially reasonable efforts and general industry standards to protect such information from any unauthorized access or disclosure. The Participant agrees and acknowledges that Privacy Policy shall be deemed accepted and agreed to by every Participant, by agreeing to participate in the Contest, shall govern all usage of any Personal Information (as defined in the Privacy Policy and/or any other information as detailed in the Privacy Policy and/or any information gathered by JioStar India under or pursuant to the Contest.

Your continued participation in the Contest shall be deemed acceptance of such Terms and Conditions. You acknowledge that no knowledge of the revisions made

shall not be a defence in any proceeding with regard to the Contest. The decisions of JioStar India for all matters relating to the Contest shall be final and binding in all respects.

The Terms and Conditions of and in relation to the Contest as stated herein, are an electronic record in terms of Information Technology Act, 2000 ("Act") and rules thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008. This electronic record is generated by a computer system and does not require any physical or digital signatures and is a legal and binding agreement between the Participant(s) and JioStar India, that states the terms that govern the Participant's participation as stated herein and through the social media platforms and/or any other platform as communicated hereunder. By clicking on the 'Submit' icon, the Participant(s) agrees to have read and understood the Terms and Conditions and hereby unconditionally consents, agrees and undertakes to abide, be bound by and adhere to the Terms and Conditions stated herein and respective terms and conditions of the Social Media Platforms and/or any other accounts/ modes through which they have chosen to participate. These terms and conditions contained herein shall subsist until the end of the Contest Period and /or any such extended duration as may be deemed fit by JioStar India and hence, the rules shall continue to apply on the Participants.

By participating in the Contest, it is deemed that the Participant(s) have read, understood, accepted and agreed to unconditionally abide with all the Terms and Conditions of the Contest.

## **1. ELIGIBILITY CRITERIA**

- i) Participant(s) must be citizens of India and above 18 years of age, residing in the state of Tamil Nadu during the Contest Period. The Participant(s) should not have criminal conviction or an arrangement or a contract that prevents the Participant(s) from participating in the Contest.
- ii) Participation by minors shall not be allowed in any manner, and any entries submitted in the Contest by a Participant(s) who is below 18 years of age shall be automatically disqualified.

- iv) By participating in the Contest, the Participant(s) represent and warrant that their Entry shall not be in breach of any third -party rights or defame/offend any person, sect, cast, etc. and that it shall not infringe any rights including the copyright of a third person/party.

### **4. GRATIFICATION DETAILS**

- i) Each Winner(s) of the Contest shall receive a personalized friendship band bearing the name of the friend as submitted by the Participant in the Google Form ("**Prize**"). The Prize shall be dispatched by or on behalf of JioStar India to the delivery address provided by the Winner. JioStar India shall not be responsible or liable for any delay, loss, damage, non-delivery, or misdelivery of the Prize

due to incorrect or incomplete information provided by the Participant, courier or logistics issues, third-party service failures, force majeure events, or any circumstances beyond JioStar India's control. In the event the Prize is unavailable or cannot be delivered for any reason whatsoever, JioStar India reserves the right, at its sole discretion, to substitute the same with an item of similar value or to cancel such dispatch without any further liability

ii) Terms And Conditions for the Prize:

- a) JioStar India reserves the right to change the Prize at any time at its discretion.
- b) The Prize will be sent to Winner(s) on the address provided by the Winner(s).   9. For the avoidance of doubt, the Winner(s) acknowledge and agree that JioStar India reserves the right to require removal of, and/or to remove or disassociate itself from, any post or tag made by a Winner(s) tagging the Channel, if the Selfie or such post is not in compliance with applicable laws or JioStar India's policies. Each Participant hereby agrees to be bound by the terms and/or by any subsequent revisions of the Terms and Conditions ("**Revised Terms**") and the Policy. JioStar India reserves the right to amend, add or delete any of the Terms and Conditions and/or Policy at its sole and absolute discretion without further notice. The Revised Terms (if any) shall supersede all prior terms.
- (ii) JioStar India may at its sole discretion extend or curtail the Period of the Contest or may suspend or abandon the same at any time without any prior notice of the same.

- (xxiii) By participating in the Contest, it shall be construed that the Participant(s) and/or the Winner has waived his/her right to raise any dispute with regard to the Contest and/or the Prize and/or any decision of JioStar India, in any manner whatsoever
- (xxiv) The Participant(s) and/or the Winner(s) shall fully indemnify, defend and hold harmless, JioStar India its affiliates, officers, directors, employees and agents (collectively the "Indemnified Persons") from and against any and all losses, claims, actions, damages, liabilities, penalties, costs and expenses, (including without limitation reasonable attorneys' fees and court fees) (collectively "Losses"), that the Indemnified Person may incur or suffer or likely to incur or suffer as a result of or arising out any (i) breach of any Terms and Conditions hereunder; (ii) willful misconduct or negligent acts or omissions; (iii) any claims by any third party for any losses, damages, costs, expenses, injuries suffered by such third party, arising out of or in relation to the Participant(s) and/or the Winner(s) during the Contest and/or enjoyment of the Prize.
- (xxv) In case of any dispute or other matter arising in reference to the Contest and/or the Prize the Courts having jurisdiction to adjudicate the same shall exclusively be the courts at Chennai, Tamil Nadu, India.
- (xxvi) The decision of JioStar India in connection with the Contest will be final & binding and is non-contestable.
