

TERMS & CONDITIONS
Disney Channel Summertastic Contest ("Contest")

1. The Contest is organized by JioStar India Private Limited ("**Organizer**") and is open to all individual participant (the "**Participant(s)**") who shall, as on **May 11, 2026**:
 - (i) Ages between 4 to 14 years,
 - (ii) have a valid proof Indian citizenship,
 - (iii) be permanent residents of India;
 - (iv) viewers of the *Disney Channel* in India ("**Channel**");
2. Participation by minors will be deemed as participation with the prior unconditional consent and knowledge of the Participant's parents/guardian. It is made abundantly and evidently clear that such Participants are participating in the Contest with the consent and assistance of their parents/guardians. Accordingly, the Participants shall provide all the necessary documents/proof as required by the Organizer upon its request in this regard. The validity of such proof shall be determined by Organizer at its own discretion. All the Terms and Conditions, Rules applicable on Participants/Winner shall deemed to also apply on the parents/guardians of such Participants/Winner. Any references made to the "Participant/(s)" herein shall deemed to mean and include their parents/guardian.
3. The Contest shall commence on 11th May, 2026 at 10:00 AM and shall conclude on 30th May, 2026 at 01:00 PM or any other date as decided by the Organizer ("**Contest Period**"). Contest Submission received after the Contest Period shall not be entertained and shall be considered ineligible for the Contest.
4. **Modes of Participation:** To participate in the Contest, the Participant shall be required to do the following:
 - a) Participants will be required to tune into the broadcast of the Channel every weekday (Monday to Friday) between 10:00AM to 01:00PM during the Contest Period.
 - b) Participants must look for a question related to their favourite character during the slated time period as specified in a) above where a QR code will be shown along with a question. Participants will be required to scan the QR code using their mobile device. Once the Participant scans a QR code, it will open a pre-loaded message on WhatsApp on the Participants' mobile device. The Participant will need to send this message on WhatsApp from the WhatsApp link. ("**Contest Submission**").
 - c) Before answering the question, the Participant will be sent a message on Whatsapp, via the WhatsApp link.
 - d) The Participants will be required to (i) provide details such as Participant's name, city, contact number, Participant age, email address, and (ii) Read and click on the check-box provided in the Form including all the consents and thereafter click on the 'SUBMIT/YES' button or such other button/option provided therein. The Participant may not proceed with participation without providing such consent to Organizer.
 - e) Every Participant to qualify as winner will have to answer a question that shall have 3 (three) options out of which one of the options would be the right answer to that question. A Participant can send their answers to the questions asked through the WhatsApp link during the Contest Period
 - f) There will be a total of up to 6 (six) questions every weekday (i.e. Monday to Friday) throughout the Contest Period.
 - g) A Contest Submission will be considered as valid only if it has been submitted as per the instructions, technical specifications and format provided in clause 4(a) to 4(f) above, failing which a Contest Submission shall be considered as disqualified.
5. By participating in the Contest, the Participant agree to be bound by any rules, regulations, guidelines or policies ("**Rules**") associated with the Contest and agree to be bound by any decisions made by the Organizer, including any interpretations of such Rules by the Organizer.

6. Specific Representations and Warranties

Each Participant represents and warrants that;

- a. his/her participation is voluntary with his/her own free will and consent and is not forced to participate in this Contest;
- b. he/she has read and accepted these Terms and Conditions.
- c. that he/she will comply with all the Rules associated with the Contest including but not limited to the Terms & Conditions mentioned herein and on <https://www.jiostar.com/legal-terms-policies/> including the terms

of use, privacy policy and such other rules and regulations set out therein and by any third party platforms which the Participant by virtue of participation in this Contest is bound by and agree to be bound by any decisions made by the Organizer, including any interpretations of such Rules by the Organizer and associated with the Gratification (if applicable), and the Participant shall be liable for any breaches/violation/non-compliance.

- d. the Contest Submission is and will be in adherence and compliance to all the, rules, terms, policy that have been published, along with any additions, modifications, renewals, revisions to the terms that may come into existence in the future.
 - e. the Contest Submission provided by the Participant shall not defame/offend any person, sect, cast, etc. and it shall not be obscene, vulgar, defaming, denigrating women, offensive/insensitive to animals, pets and/or to any person/human (whether living or dead), artist, celebrity or children, hurting religious/moral/social/political sentiments, depicting violence, or against the morality/public policy of India or/and the internal policies of the Organizer.
 - f. The Contest Submission has been submitted with the unconditional and willful consent of the Legal Guardian (if the Participant is a minor).
 - g. the Contest Submission shall be original and shall not be in breach of any third-party rights including but not limited to any rights in any copyrighted works and underlying works, that it shall in no manner infringe any rights including but not limited to the copyright trademark, privacy, publicity or other personal or proprietary rights of the Organizer and/or any third person/party.
 - h. that no license fee, royalties, charges, etc. are payable to any person/party/copyright society anywhere in the entire world, in relation to the Contest Submission and all rights are cleared.
 - i. that the Contest Submission shall be suitable for presentation in a public forum, in sole determination of the Organizer.
 - j. Contest Submission shall not promote or advertise or tag any product(s), service(s) or brand(s).
 - k. Contest Submission shall not contain content that depicts alcohol or tobacco or drugs or anything illegal. Contest Submission shall not in any manner depict or encourage harm or injury to any person, party, animal.
 - l. The Participant will be solely responsible and liable to ensure that any and all comments, replies, reposts, made to their respective Contest Submission by any third Party (except the Organizer), is in compliance and adherence with these Terms and Conditions applicable on the Contest Submission.
7. In the event of any violation/breach to any of the aforementioned representation and warranties and any other term or condition, the Participant(s) shall at the discretion of the Organizer be disqualified from the Contest with immediate effect. The Organizer reserves the right to delete/remove any Contest Submission that violates these Terms and Conditions. By participating in the Contest, the Participant also agrees that they shall solely be liable for any and all actions (criminal/civil), claims arising therefrom and shall also be liable to indemnify the Organizer, its affiliate and group companies and their respective officers directors, employees, partners of the Organizer for any loss, expense, liability, claim, dispute, disrepute, disruption caused to any of them, including attorney fees.
8. The Terms and Conditions of and in relation to this Contest as stated herein, is an electronic record in terms of Information Technology Act, 2000 ("Act") and rules thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008. This is a legal and binding agreement between the Participant and Organizer, that states the terms that govern the Participant's participation in the Contest. By making the Contest Submission, the Participant agrees to have read and understood the terms and conditions and hereby unconditionally consents, agrees and undertakes to abide, be bound by and adhere to the terms and conditions stated herein.
9. The Organizer reserves the right to disqualify the Participants immediately from the Contest if Participants have supplied untruthful, inaccurate, incorrect or misleading details and/or information, of any nature and/or have failed to abide by the Rules and/or are in breach of the terms hereof and/or have not provided the valid consents in the Contest Submission.
10. **Selection of a Winners:**
- a) At any time during or after the end of the Contest Period, as determined by Organizer at its sole discretion, out of all the eligible Contest Submissions received during the Contest Period the Organizer shall select a maximum of 16 (sixteen) participants as "Winner/Winner(s)" (a total of 15 daily Winners and 1 Mega Winner).
 - b) There shall be 15 (fifteen) daily Winners who have correctly answered the daily questions and 1 (one)

- Mega Winner who has given the maximum number of correct answers throughout the Contest Period.
- c) In the event of a tie Winner shall selected through randomizer method.
 - d) Such Winner(s) who fulfill all of the requirements set out in these Terms and Conditions including submitting of valid Documents (defined herein below) to the satisfaction of Organizer shall be declared the Winner(s) and shall be entitled to the Gratification (as defined below).
 - e) The Participants understand that answering all questions correctly shall not entitle them to be the be selected as a Winner, the decision regarding selection of Winners shall be as per the sole discretion of the Organizer.
11. Notwithstanding the above, it is hereby clarified that in the event that the Organizer is of the opinion that none of Contest Submission is eligible to be selected, then the Organizer may exercise its discretion not to select any participant as Winners. The decision of the Organizer shall be final on this regard and no questions or communications shall be entertained in this regard.
 12. Participant/Guardians hereby consents the Organizer to reach out the Winner for telephonic verification and further verification of documents at any time after the Contest Period. Participants hereby acknowledge and agree that the decision of the Organizers in this regard particularly with respect to the timelines for conducting the telephonic verification and document verification shall be final and binding and no questions shall be raised in this regard.
 13. **Verification:** The Participant/Guardians agree and consent that before being considered and declared as a Winner, the Participant may be contacted anytime by Organizer on their e-mail id/contact number provided by them in the Form as determined by Organizer and such contacted Winner shall be required to immediately provide Organizer with such information pertaining to them as asked for by the Organizer (including mobile number, e-mail address, residential address etc.) and also the following documents immediately upon such request by Organizer:
 - a) PAN card
 - b) Proof of identity cum permanent address proof – Aadhar card / Election card/Passport/ permanent Driver's License
 - c) copy of NOC/consent of guardian/parent
 - d) Birth Certificate/Identify certificate from schools such other documents as may be required by the Organizer from time to time, in such manner as required by Organizer. It is hereby clarified that information and documents shall pertain to such Participant only, and not of any other person.
 14. The communication to the Winner(s) would be done as per the timelines decided by the Organizer as per its own discretion. The declaration of Winners shall be communicated individually through email sent to the Participants by the Organizer from an official email ID and shall not be made public through the Channel or any social media platforms or any other modes of communication. Notwithstanding the number of Winners as specified in 10 (a) and (b) above, the final number of Winners shall be determined by Organizer at its sole discretion based on the quality of the participation /Contest Submission received for the Contest.
 15. Participants hereby acknowledge and agree that the decision of the Organizer with respect to timelines for selecting and declaring the Winners, the manner/mode/platform of communicating the Winners shall be final and binding and no questions shall be raised in this regard.
 16. For sake of clarity, a Participant will be considered as final Winner(s) only when he/she has been specifically contacted and informed that he/she has been selected as a Winner by the Organizer and not merely when he/she has been contacted by Organizer for verification or any other purpose.
 17. Organizer reserves the right to disqualify a Participant/Winner at any time, if Organizer is of the opinion that the details and/or documents provided by the Participant/Winner is not to the Organizer's satisfaction. No questions or communications shall be entertained in this regard for any reason. Furthermore, the Organizer may at any time either forfeit the Gratification or announce another Winner in place of the originally announced Winner if:
 - (i) the documents or details of the Participant/Winner is not correct in the opinion of the Organizer; or
 - (ii) documents so required are incomplete, misleading or untrue; or
 - (iii) the Winner/ Participant and their respective guardians, parents do not have valid documents as may be required for the purpose of the Gratification;
 - (iv) the Winner/ Participant and respective guardians, do not sign the confidentiality, release letter or any other documents required, if any, by Organizer in relation to the Gratification; or
 - (v) if the Winner do not approach the Organizer at the contact details provided by the Organizer, immediately upon such request by Organizer.

18. The Participant unconditionally and freely consents to the Organizer to collect, store, use and process their personally identifiable information which shall include their name, photographs, complete address, date of birth, email address, social media profile URL (as applicable), etc. for the purpose of enabling registration of a Participant or to make the Gratification available to the Winner and /or to enable the Organizer to administer and promote the Contest ("**Personal Information**"). If Participants/Winner do not truthfully provide all requested Personal Information, the Organizer may determine that such Participants/Winner are not eligible to win the Gratification in this Contest. The Participant hereby willfully consents and agrees that Organizer can use the Personal Information to contact the Participant to share notifications, promotional SMS/communication, re-marketing for any of the contests, activities, campaigns etc. that may be conducted by Organizer in the future.
19. The Participant unconditionally and freely provides their consent to the Organizer to pass the Personal Information of the Participant/Winner to others assisting the Organizer in this regard, including its affiliates, associates, authorities, agents, sponsors, employees, prize suppliers, distributors, deliverers and service providers (as applicable).
20. If applicable, the parents/guardians of such Participant/Winner(s) may be required to sign the release form in the format required by the Organizer, for and on behalf of the Winner(s). Further, such Participant/Winner(s) shall be required to submit to the Organizer, a document evidencing the fact that his/her participation in the Contest was approved by and was subject to the prior unconditional consent and knowledge of the his/her, parents/guardian.
21. **Gratification:**
- (i) The daily Winners of the Contest shall get one electronic gadget worth approximately INR 30,000/- per gadget as per the discretion of the Organizer. The Mega Winner shall win a fully paid vacation for the Participant and up to 3 of their family members at a destination as decided by the Organizer. Details of the vacation including the destination will be provided by the Organizer to the Mega Winner at a later date after the Contest Period.
 - (ii) It is hereby expressly stated that Organizer shall not be responsible to bear or reimburse any costs and expenses incurred by the Winner in availing the said Prize and/or incurred otherwise including but not limited to the travel, ground transportation / internal travel, accommodation, food, beverages etc. It is hereby expressly stated that the Winner shall be solely responsible to arrange and pay for all costs / expenses incurred by the Winner in availing the said Prize and/or incurred otherwise. Further, Winner grants Organizer irrevocable consent in perpetuity to the use his/ her name, photographs, video tape taken during the meet and greet event in any and all applications including but not limited to advertising, commercials, promotion, stories, text, articles and commercial exploitation, in any and all media forms, including but not limited to radio, broadcast and television, newspapers and magazines at any time without the Participant(s)/Winner further knowledge or consent.
 - (iii) Income tax or any other statutory taxes, duties or levies as may be applicable from time-to-time, shall be payable by the Participant. In case the Participant fails to comply with the applicable laws or pay the requisite taxes, costs, levies, charges, expenses, etc., if any, the Participant shall indemnify SIPL of any losses, expenses, costs, actions, claims, etc. for the same.
 - (iv) Notwithstanding paragraph (ii) above, it is expressly stated that for the Gratification for the Mega Winner, the Organizer shall cover the following expenses for the Mega Winner and their 3 (three) family members:
 - a) Pick up from the Mega Winner's home city, if such city is not Mumbai;
 - b) Flight to Mumbai (basic economy class or equivalent);
 - c) Accommodation in Mumbai;
 - d) Flight (including return flight) from Mumbai to the destination (basic economy class or equivalent);
 - e) Cost of acquiring visa, if applicable;
 - f) Stay at an accommodation as per the Organizer's discretion;
 - g) Meals at the accommodation based on Organizer's internal policy;
 - h) Return airport transfers;
 - i) Flight back to the Mega Winner's home city (basic economy class or equivalent);
 - j) Drop to the Mega Winner's home;
22. Organizer shall have the sole right to determine the timeline when the Gratification shall be shared with the Winner on email. No questions or communications shall be entertained in this regard for any reason.

23. Mere participation in the Contest, making the Contest Submission, or answering any/all the questions correctly does not entitle the Participants to win the Contest or the Gratification. The selection process may vary and shall be as per the Organizer's sole discretion. The Participants /Winner and/or any third party shall have no right to question the process of selection. The Organizer may determine the correctness, quality, creativity and validity of the Contest Submission and Organizer's assessment in this regard shall be final.
24. The Gratification is subject to availability and the terms and conditions of any third-party service providers. Events may occur that make the awarding of the Gratification (or any part thereof) impractical or inappropriate due to unforeseen circumstances or reasons beyond the control of the Organizer. In this situation, the Organizer may vary or amend or cancel the Gratification and the Participant agrees that no liability shall attach to the Organizer or any third-party partners of the Organizer as a result thereof. It is hereby clarified that the Organizer shall have the right, at its sole discretion, to change/modify/replace or omit the Gratification and the Winner shall not have the right to claim any damages or monies from the Organizer.
25. The Winner hereby represents and warrants that they will comply with all the Rules associated with the Contest including but not limited to the Terms & Conditions mentioned herein and associated with the Gratification, and that the Winner shall personally be liable for any breach thereto. Selection of a Participant and/or Winner shall not relieve them of the Terms and Conditions applicable to the Participants. For avoidance of doubt the Terms and Conditions shall be applicable on the Winner irrespective of the change in their status from a Participant to a Winner.
26. Access and use of WhatsApp link by the Participants:

By accepting these Terms and Conditions, the Participant understands and accepts that:

- (i) The Organizer may use third party service provider(s) for generating and operating the WhatsApp link for the purpose of conducting the Contest and the Organizer shall not be liable for any issues relating to the WhatsApp link including but not limited to issues related to access, malfunction, or
- (ii) The Organizer grants the Participant a non-exclusive limited license to use WhatsApp link for personal, non-commercial purposes as set forth in these Terms and Conditions.
- (iii) There is no entry fee applicable for accessing, logging into and interacting with WhatsApp link or participating in the Contest and, unless otherwise stated, no gratification or prize will be offered by the Organizer for Participant's participation on WhatsApp link.
- (iv) Organizer retains the right, at its sole discretion, to deny service or use of WhatsApp link or to participate in the Contest to anyone at any time and for any reason.
- (v) Organizer has the right to temporarily or permanently suspend access to the whole or any part of WhatsApp link for any technical/operational reason or for any other reason whatsoever at its sole and absolute discretion. Organizer shall be under no liability to the Participant in the event of non-availability of WhatsApp link or any part thereof for any reason whatsoever.
- (vi) Organizer shall not be responsible for any problems or technical malfunction of any computer online systems, servers or providers, computer equipment or software due to technical problems or traffic congestion on WhatsApp link or due to use of WhatsApp link or any part thereof, including any injury or damage to Participant's or any other person(s)' computer/device related to or resulting from interaction with WhatsApp link or downloading materials from WhatsApp link.
- (vii) Participant acknowledges and agrees not to either directly or through the use of any device, software, internet site, web-based service, or other means remove, alter, bypass, avoid, interfere with, or circumvent any copyright, trademark, or other proprietary notices marked on the content displayed on the WhatsApp link platform ("Content"), or any digital rights management mechanism, device, or other content protection or access control measure associated with the Content including geo-filtering mechanisms.
- (viii) Participant agrees not to either directly or through the use of any device, software, internet site, web-based service, or other means copy, download, capture, reproduce, duplicate, archive, distribute, upload, publish, modify, translate, broadcast, perform, display, sell, transmit or retransmit the Content or create

any derivative work and/or material based on the Content.

- (ix) Organizer owns and retains all rights to WhatsApp link. Participant further agrees that the Content made available on WhatsApp link is owned or controlled by Organizer and/or its service providers/licensors. WhatsApp link and the Content are protected by copyright, trademark, and other intellectual property laws.
 - (x) Trademarks, logos and service marks shown on WhatsApp link are registered trademarks of their respective owners. Nothing in Participant's use of WhatsApp link shall be interpreted as granting any license or right to use any image, trademark, logo or service mark made available on WhatsApp link.
 - (xi) Participant waives their right to any claim based on the detrimental effects or results of any reliance placed by the Participant on any information or data made available on WhatsApp link. Content and data made available on WhatsApp link may not be current or up to date for any purpose.
 - (xii) Organizer shall have the right to use, edit, modify and/or combine comments, and any other interaction of the Participant on WhatsApp link for any purposes whatsoever. The Participant hereby waives off his/her "Moral Rights" in respect of the above or any part thereof. The Participants shall do all acts and execute all documents in such manner and at such location as may be required by Organizer in its sole and absolute discretion to protect, perfect or enforce any of the rights granted or confirmed to Organizer herein.
 - (xiii) Participant shall ensure that their usernames, comments, and other content and any other interaction of the Participant on WhatsApp link: (i) does not use materials that belongs to another person and in which the Participant does not have any rights; (ii) is not blasphemous, indecent, immoral, abusive, offensive, against the applicable laws or libelous and/or is contrary to any law in force; (iii) is not grossly harmful, harassing, defamatory, obscene, pornographic, pedophilic, libelous, invasive of another's privacy, hateful, or racially, ethnically objectionable, disparaging, relating or encouraging money laundering or gambling, or otherwise unlawful in any manner whatever; (iv) does not harm minors in any way; (v) does not infringe any patent, trademark, copyright or other proprietary rights; (vi) does not violate any law for the time being in force; (vii) does not deceive or misleads the addressee about the origin of such messages or communicates any information which is grossly offensive or menacing in nature; (viii) does not impersonate another person; (ix) does not contain software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer resource; (x) does not threaten the unity, integrity, defense, security or sovereignty of India, friendly relations with foreign states, or public order or causes incitement to the commission of any cognizable offence or prevents investigation of any offence or is insulting any other nation; and (xi) does not contain any confidential information.
 - (xiv) At all times the Participant shall be solely responsible for any non-compliance with or breach of any applicable laws and regulations in connection with their access and use of WhatsApp link. It is clarified for the avoidance of doubt that Organizer shall not be responsible in any manner whatsoever for the above and shall have no liability whatsoever (whether in law or equity or otherwise) in respect of the above.
27. The Organizer shall not be responsible for any loss of entries/submissions for any reason, whatsoever including, due to any problems caused by telephone lines, service providers, network breakdowns, computer service delays, interruptions, network failures or overloads, or for lost, misdirected or misplaced entries/submissions, or for entries/submissions received after the Contest Period or for any reasons beyond the control of the Organizer. Any dispute in connection to the same shall be settled between the Participant and the service provider without involving Organizer. The internet charges etc. that may arise from participating in the Contest will be borne by the Participant. All incidental costs, if any, that may arise from participating in the Contest will be borne by the Participant solely.
28. In the event of unforeseen circumstances beyond the control of the Organizer, and the Gratification not being made available to the Winner or the said Contest/ Gratification being cancelled, the Winner shall not have the right to claim any damages or monies from the Organizer and by participating in this Contest, the Winner waive their right to make any such claims against the Organizer.
29. The Participants/Winner acknowledge that they do not have any medical, physical and/or emotional condition which can jeopardize their eligibility for participation in the Contest.

30. The Winner acknowledges that the Organizer shall not be liable for any mishap, injury, accident, untoward incident, physical harm of any nature, death, loss of life or limb, etc., caused to them including, either before, during or after availing the Gratification; or before, during or after the Contest and no such accident (etc.) will be attributed to the Organizer and the Organizer shall not be held responsible for the same nor shall the Organizer be liable to indemnify or make good any claim being raised against it, for whatsoever nature..
31. Employees (including their immediate family) of the Organizer, its affiliates and associates and sponsors, are not permitted to participate in the Contest.
32. The Participants hereby agree and undertake that mere announcement/declaration of being announced as a Winner shall not entitle him/her to the Gratification. Only upon fulfilling all Rules mentioned herein, to the satisfaction of the Organizer, including compliance with all precautionary measures and agreeing to the terms of the release letter, shall the winning be validated. It is the Participants'/ Winners' responsibility to ensure that their Personal Information is always updated and accurate in order to be able to receive the Gratification/ notification in time.
33. The Participants hereby agree and undertake that they shall not accept or undertake to accept/give or undertake to give, either directly or indirectly, any gifts, commission or other favor, of any kind whatsoever, to facilitate their winning the Contest. Any knowledge of such an act shall lead to immediate disqualification of such Participants and the Organizer shall be entitled to take any/all actions against such Participants, as deemed fit by it.
34. The Organizer shall not be responsible for the quality or deficiency of the Gratification and no claim or request, whatsoever, in this respect shall be entertained by the Organizer.
35. It is clarified that the Winner/Participant shall, in no circumstance, have any rights or claims against the Organizer.
36. The Organizer is not responsible for any errors or omissions in the Terms & Conditions contained herein. All information provided in the Contest is provided "as is" without warranty of any kind. The Organizer makes no representations and disclaims all express, implied and statutory warranties of any kind to the Participants and/or the Winner and/or any third party including, without limitation, warranties as to accuracy, timeliness, completeness, merchantability, or fitness for any particular purpose.
37. Under no circumstance, shall the Organizer and/or its parent, subsidiaries, associates, affiliates and group entities, and their respective directors, employees, officers, agents or representatives be liable to the Participants and/or the Winner or any third party for any lost profits or lost opportunities, indirect, special, consequential, incidental, or punitive damages whatsoever, even if the Organizer has been advised of the possibility of such damages. The Participants and the Winner specifically agree not to file in person/through any family member and/or any third party, any applications, criminal and/or civil proceedings in any courts or forum in India against the Organizer, its parents, subsidiaries, associates, affiliates and group entities, and their respective directors, employees, officers, agents or representatives to claim any damages or relief in connection with the Contest.
38. The Organizer may, at any time, at its discretion, cancel/extend/suspend the Contest, change these Terms & Conditions, the Rules mentioned herein, and/or alter/change/modify the mechanism of the Contest and/or selection process and/or the Gratification and/or the number of Winner(s) for the Contest, at any time, without prior notice, and the Participants/Winner acknowledge that such change shall be final, binding and irrevocable upon them.
