

Bigg Boss – Agnipareeksha

Terms and Conditions”

The following terms and conditions (“**Terms and Conditions**”) shall govern the entire audition process (“**Auditions**”) for **Bigg Boss – Agnipareeksha** which is conducted for the purpose of shortlisting and selecting common man participants (“**Commoner Contestant(s)**”) who shall be given the opportunity for participating in the program titled “**Bigg Boss Malayalam – Season 8**” in Malayalam language (“**Program**”), based on the international format “**Big Brother**”. The Auditions shall be conducted in multiple levels/stages, and only such Participant(s) (as defined below) who successfully qualify through Level 5 of the Auditions shall be eligible for final shortlisting for participation in the Program. These Terms and Conditions shall apply to and be binding upon all individuals who are citizens and residents of India (“**Territory**”) who wish to participate in the Auditions (“**Participant(s)**” or “**You**”). The Program and the Auditions are hosted by Jiostar India Private Limited (“**JIPL**” / “**Company**”) and produced by the Production House (as defined below), and may be exhibited, broadcast and/or made available on the Company’s television channels and/or digital platforms, including but not limited to JioHotstar, as determined by JIPL from time to time (“**Channel**”).

These Terms and Conditions shall be irrevocably binding on each Participant voluntarily participating in the Auditions. To participate in the Auditions, the Participant may be required to disclose his/ her personal information to JIPL from time to time such as full name, contact number, email ID, residential address, and/or other personal information (“**Personal Information**”). JIPL is committed to protecting the privacy and the confidentiality of the Personal Information received. JIPL uses commercially reasonable efforts and general industry standards to protect such information from any unauthorized access or disclosure. Such information is dealt in the manner laid down in the [Privacy Notice](#) of JIPL. (the “**Privacy Policy**”).

By participating in the Auditions, it is deemed that the Participant has read, understood, accepted and agreed to unconditionally abide with all the Terms and Conditions and Privacy Policy. The Participant’s act of voluntarily participating in the Auditions in the manner as detailed below shall be deemed to be the Participant’s absolute acceptance to the Terms and Conditions, Privacy Policy and other Policies, as prescribed from time to time, available at the Website (as defined below) (hereinafter collectively referred to as “**Terms and Conditions**”). If the Participant does not agree to be bound or cannot comply with any of the Terms and Conditions, please do not continue. Failure to accept these Terms and Conditions or the Privacy Policy or Terms of Use or User Generated Content will disqualify the Participant’s participation in the Auditions. The Auditions shall be governed by the Terms and Conditions stated herein below and all Participants are requested herein unconditionally accept and agree to comply with and abide by the same.

You are required to click on the tab ‘**I ACCEPT**’ at the end of the page. The failure to accept these Terms and Conditions by You will disqualify your participation in the Auditions.

DEFINITIONS

“**Digital Auditions**” shall mean Level 1 and Level 2 (video auditions) of the selection process of the Auditions as detailed hereunder and shall include any additional levels as may be incorporated thereafter by the Company and/or the Production House, in the selection process of the Auditions at any point of time at its discretion, to be conducted *inter alia* in the manner as set out hereunder, which the Participant(s) is required to qualify for further Levels, if any, and qualify for participating in the Program.

“**On Ground Audition(s)**” shall mean Level 3 (Group Discussion), Level 4 (Personal Interview) of the selection process of the Auditions as detailed hereunder and any additional levels as may be incorporated

thereinafter by the Company and /or Production House, in the selection process of the Auditions at any point of time at its discretion, to be conducted *inter alia* at the Audition Center(s), which the Participant(s) short-listed in the Digital Auditions are required to qualify for further Levels and qualify for participating in the Program.

“On Air Audition(s)” shall mean Level 5 of the selection process of the Auditions as detailed hereunder and shall include any additional levels as may be incorporated thereafter by the Company and/or the Production House in the selection process of the Auditions at any point of time at its discretion, which the Participant(s) short-listed in the Digital Auditions and On Ground Auditions are required to qualify for further Levels, if any, and qualify for participating in the Program.

“Audition(s)” shall mean jointly and/or severally the Digital Auditions and/or On Ground Auditions and/or On Air Auditions and different Levels of selection process to be conducted *inter alia* in the mode and manner as detailed hereunder during the Audition Period (*as defined below*), which the Participant(s) is required to qualify to participate in further Levels for participating in the Program.

“Digital Audition(s) Period” for Level 1 of Digital Auditions shall mean the period commencing from June 6, 2026 and continuing till June 15, 2026 or such other date stipulated and/or updated by the Company and/or Production House in the Terms and Conditions, at its sole discretion, and uploaded on the website/microsite viz, <https://asianet.jiostar.com/bb8/> (**“Website”/“Microsite”**) and required to be checked by You from time to time. The period can be extended or reduced by the Company and/or Production House at its sole discretion from time to time. And Digital Audition(s) Period for Level 2 of Digital Auditions shall mean on such date(s) fixed & communicated by the Company and/or Production House, as detailed below and/or at its sole discretion, to the short-listed Participants of Level 1. The period can be extended or reduced by the Company and/or Production House at its sole discretion from time to time.

“On Ground Audition(s) Period” shall mean the period which commences on the date as communicated to the Participant via email or via any other mode of communication or on any other date stipulated and/or updated by the Company and/or Production House, as detailed below and/or at its sole discretion, to the short-listed Participants in Digital Auditions. The period can be extended or reduced by the Company and/or Production House at its sole discretion from time to time.

“On Air Audition(s) Period” shall mean the period which commences on the date as communicated to the Participant via email or via any other mode of communication or on any other date stipulated and/or updated by the Company and/or Production House, as detailed below and/or at its sole discretion, to the short-listed Participants in On Ground Audition(s). The period can be extended or reduced by the Company and/or Production House at its sole discretion from time to time.

“Audition Centre(s)” shall collectively mean the following centres/venues at Kochi, Kerala or any other locations in the state of Kerala, as decided by the Production House and /or Company at its sole discretion, where the short-listed Participant(s) in Level 2 (Video Auditions) need to make themselves available for further levels of Auditions as per the selection procedure.

“Audition Period” shall mean Digital Audition(s) Period and On Ground Audition(s) Period and the period of further Levels of Auditions.

“Commoner Contestant(s)” means 05 (five) or more (as decided by the Company and/or the Production House at its sole discretion) and shall mean the Participant(s) who are shortlisted and selected from among the other Participants participating in the Auditions, basis the mechanism as mentioned hereinbelow for the purposes of participating in the Program. The Company and/or the Production House shall have the absolute

discretion to introduce Final Participant(s) in the Auditions and/or the Program depending upon their programming requirements and without any further notice to the Participants and/or the Viewers.

“Participant(s)” means all person(s) aged 18 (eighteen) years and above as on 01st June, 2026, being an Indian citizen and resident of India and enters the Auditions /Program individually.

“Final Participant(s)”- shall mean any natural person who; (i) is at least eighteen (18) years of age on 1st June, 2026, and (ii) has been selected, shortlisted and finalised by the Company and /or the Production House, from any jurisdiction worldwide, for participation in the Program along with the Commoner Contestant(s), in accordance with such criteria and parameters as may be determined by the Company in its sole discretion.

“Exploitation/Exploit” shall mean the exploitation of the Works including along with its cognate forms and grammatical variations, means and includes the exploitation, use, alteration, broadcast, rebroadcast, communication, encryption, transmission, translation, adaptation, publication, cutting, editing, and packaging of the Intellectual Property vested in the Works, either in whole or in part, in any form/format or language, as may be decided by JIPL in its sole discretion and shall include incorporation of the Works including performances in the Program or any audio visual recording or sound recording or as may be decided by JIPL in its sole discretion as well as the conversion of the Works from one form/format to another and in relation to the Works, making of a Cinematograph Film or Sound Recording, Communication to the Public, Broadcast, Performance in Public, adaptation, reprography, reproduction, distribution, sale, commercial rental, assignment, licensing, merchandising rights, remakes, sequels, prequels, versions, translations, dubbing and/or subtitling in any all languages/dialects in the world, converting the Works for theatrical exploitation, including but not limited to the broadcasting thereof by any form of radio, internet and any and all form of television including but not limited to terrestrial, satellite, direct to home, cable, IPTV, any form of video on demand (including but not limited to Pay-per-View, Nvod, SVOD, PVoD, FVoD, AVOD made available for being seen or heard or delivered or exploited through wire or wireless including but not limited to internet, websites including but not limited to social networking websites, blogs, internet or mobile streaming or download services (whether free, pay or subscription based) computing and networking devices, mobile/telecommunication system based platforms, mobile TV, theatrical or non-theatrical or any other means whether now known or existing or in commercial use or hereinafter invented or developed in the future in and to the Intellectual Property and all elements thereof. The capitalized terms ‘Broadcast’, ‘Communication to the Public’, ‘Cinematograph Film’, ‘Performance /Perform in Public’, ‘Sound Recording’, ‘Visual Recording’ shall have the same meanings as defined in the Indian Copyright Act, 1957 as amended from time to time and all analogous rights subsisting under the laws of each and every jurisdiction throughout the world.

“Intellectual Property” means and includes all performances, performers’ rights, publicity rights, brands, rights if any vested in the Participant relating to or in the footage owned by the Company, concepts, confidential information, copyrights, databases, designs, formulae, franchises, goodwill, know-how, licenses, ‘look and feel’, music (including songs, sheet music, lyrics and remixes), permits, proprietary information and knowledge, scripts (and their sound recordings), segments, set designs, service marks, technology, titles, trademarks, trade names, trade secrets, format rights, and all other allied, ancillary and subsidiary rights in any and all media whether now known or subsequently invented, as well as all other intellectual property as is commonly understood and recognized as such by applicable law, (past, current or future) industry usage, or otherwise.

“Level(s)” shall mean collectively Level 1, Level 2, Level 3, Level 4 and Level 5. The term “Level(s)” shall be construed accordingly to refer to anyone (1) particular level of the Auditions as signified by the corresponding number and can be changed/altered at the sole discretion of the Company and/or the Production House.

“Production House” means the Production House (if any) engaged by the Company for the production of the Program.

“Recordings” shall mean and include the audio-video/audio or video of the participation process/performance of the Participant(s) at every and/or any level of the Auditions, including any interaction of the Participant with the Company and/or the Production House and/or fellow Participant and/or any representative of the Company and/or the Production House, if any, during the Auditions or the Bigg Boss – Agnipareeksha (*as defined below*) or the Program or any related series of sound recordings and video recordings which have been shot/filmed/recorded during the Auditions or the Bigg Boss – Agnipareeksha or the Program, which may be used for Exploitation by the Company in any manner as it deems fit, anywhere in the world in perpetuity.

“Studio” means any venue/ location as deemed fit by the Company and/or Production House for filming of the Recordings and/or the Bigg Boss – Agnipareeksha (*as defined below*) and/or the Program.

“Works/Materials” shall mean and include Videos, Recordings, Footage (*as defined below*), Entries, On Ground Entries, footage of Promotional material including any form of artistic works, works of authorship, performances and services made by the Participant(s) or compilation, data which is developed, created, discovered, invented or otherwise brought into existence by the Participants during the course of Auditions/Program/Bigg Boss – Agnipareeksha and any other Intellectual Property created/ generated by the Participants during the course of participation in the Auditions/Program/ Bigg Boss-Agnipareeksha Series.

PRINCIPAL RULES

1. Eligibility criteria for Participants:

- (a) Participants who are aged 18 (eighteen) years and above as on 01st June, 2026;
- (b) Participants who are Indian citizens and resident of India, as per applicable laws;
- (c) Who can fluently speak in Malayalam; and
- (d) Such other criteria provided under these Terms & Conditions.

2. The Auditions are an integral part of the Program. The Digital Auditions and On Ground Auditions will be conducted during the Audition Period at absolute discretion of the Company. The Digital Auditions will be conducted via the Website during the Digital Audition Period and the On Ground Auditions shall be conducted in the Audition Centre(s) located in the Territory. The interested Participant(s) shall be required to upload the required information on the Website and shall be present at such Audition Centre(s) during the Audition Period to register themselves in the manner provided below and/or shall be required to participate in the Auditions in the manner provided below.

3. The On Ground auditions may or may not take place at the sole discretion of JIPL and/or Production House. JIPL/Production House is under no obligation to go for On Ground Auditions or shooting of the Program and/or Bigg Boss – Agnipareeksha and is also under no obligation to inform prospective Participants about the same.

4. The Company shall promote the Auditions through on-air (promos, astons, bugs *etc.*), print, radio, online, official social media pages/handles of the Company or any other manner as the Company may deem fit, at its sole discretion, stating the mechanism by which the Participant(s) can participate in the Digital Auditions, wherein the Participant(s) can get details of the Audition Period, timings, and other

details. By participating in the Auditions and/or if shortlisted and/or selected for participation for any Level of Auditions, the Participant agrees and grants an irrevocable right and consent to record his/her to performance on any medium as deemed fit by the Company and/or the Production House at its sole discretion for Exploitation as deemed fit by the Company.

5. Procedure to register

(a) To register and to participate in the Auditions, the Participant(s) shall:

- i. Login to the Website at his/her sole discretion to register for the participation in the Auditions by submitting / furnishing his/her valid Indian Mobile Number, and a valid email id. It is clarified that the option to exercise registration either through a registered mobile number or email id is the discretion of the Participant and it is further clarified that for the purpose of registering and participating in the Auditions it is mandatory that the valid Indian mobile number submitted by the Participant should be registered in his/her name only, failure to comply with this pre-requisite will automatically cause such Participant's registration / Entry (*as defined below*) to be invalid.
- ii. Upon entering into the Website, a registration form shall be displayed in the Website and the same is required to be filled by the Participant(s) with all the relevant and necessary details as stated and enumerated therein and submit/ upload the Video (*as defined below*) on Website, in accordance with the requirements and criteria as laid down for the Auditions herein. The Participant(s) shall as part of the registration form submit the following personal details of the Participant including but not limited to date of birth, full name, gender, age, address, education, nationality, city of residence, languages spoken, brief of the Participant(s) along with the Parent(s)/Spouse(s) name, email ID, contact number(s), emergency contact number, the name of their state/city where they reside, photo(s) of the Participant(s), (if requested) and/or any other information/documentation as sought by the Company, at its sole discretion during the Audition Period ("**Personal Information**") in a manner and form, as requested and /or prescribed on the Website. For avoidance of doubt, for the purposes of participating in the Auditions during the Audition Period set out hereinabove, registering through a valid mobile phone number and/or a valid mail ID vide the medium of the Website is mandatory for all interested Participants.
- iii. It may be clarified that the Participant(s) participating in the Auditions may register on the Website only once either through a particular mobile phone number and/or email ID of themselves. Accordingly, the Personal Information required by the Company may only pertain to the Participant registering himself/herself for the Auditions. It is further clarified that if the Participant has already registered and submitted Entry (*as defined below*) and /or uploaded Video(s) on the Website multiple times through a particular registered mobile number and/or specific email id (as applicable), then only the first Entry from that particular registered mobile number and /or email id shall be considered and all subsequent Entries and /or Video(s) shall be deemed invalid and shall be automatically disqualified and not taken into consideration for further participation in the Auditions. Additionally, it is clarified that a specific Participant cannot register and submit Entries (*as defined below*) and /or upload Video(s) on the Website through multiple registered mobile numbers and/or multiple email id's. In such cases only the first Entry submitted by the Participant through a particular mobile number and /or email id shall be considered, and the others shall be deemed invalid.
- iv. Once the mobile phone number and /or email id (as applicable) is registered in the manner as stated therein, an OTP (One Time Password) will be sent to the registered mobile phone number and/or email id (as applicable) submitted by the Participant(s). The Participant(s) will be required to mention the OTP received on their registered Mobile Number and/or email id within the permitted time as mentioned therein on the Website, post which, the Participant will be able

to proceed further with the registration process. In the event the Participant(s) fails to verify /authenticate the validity of his/her mobile number and/or email id or validate the OTP during such mobile verification and/or email verification by the Company, the mobile number and/or email id shared by the Participant is found to be false and /or unauthenticated and /or fabricated and /or the said mobile number not registered in the Participant's name, then the Company shall have the right to forthwith disqualify the Participant from further participation and his/her Entry shall immediately be considered to be null and void.

(b) Procedure to upload the Video:

- i. Once the Participant(s) shares the Personal Information required in the registration form, he/she shall record one (1) self-introduction video narrating their profile, uniqueness and the reason why he / she considers himself / herself an apt candidate for being selected as a Contestant of the Program and/or showcasing any special talent, which should be in Malayalam/English language; such video shall have a maximum duration of 03 (three) minutes with a maximum file size of 50 Mb (“**Video**”)
- ii. The Participant shall thereafter upload the Video on the Website by following the instructions and as per the terms specified on such Website and click on “**Submit**” button. Once the Video is uploaded on the Website, a confirmation message is displayed on the screen of the Website. The Company and/or Production House will not send any confirmation SMS/e-mail notification to the Participant in this regard for confirming and acknowledging the registration.
- iii. If at any point of time the Company finds that the mobile number / email ID shared by the Participant(s) is found to be false and /or unauthenticated and /or fabricated, then Company and/or Production House shall have the right to forthwith disqualify such Participant from further participation and his /her Entry shall immediately be considered to be null and void.
- iv. The Video uploaded on the Website may be in .mp4, .mov, .wmv., format and shall not exceed the size of 50 mb. For the purposes of Auditions, by uploading and /or submitting his/her Video on the Website, the Participant agrees and undertakes that they are unconditionally bound by the Terms and Conditions.
- v. The Participant(s) agrees and undertakes that all Personal Information, provided by him/her at the time of registration is true, correct, and accurate. The Participant hereby represents, covenants and declares that (i) the Video is original and is performed by the Participant(s); (ii) the Video does not and will not constitute any infringement of copyright or any right of privacy, or rights in any other form of intellectual property, or any other personal or property right whatsoever of any person or entity, or constitute a libel or slander, or hurts the religious sentiments of people worldwide or be defamatory of any person deceased or alive or blasphemous in its content and that he/she fully owns and controls all rights and interests including all intellectual property rights in the Video, such material and all rights therein and that no other person or party has right or interest in the Video as a co-owner, partner, mortgagee, charge holder or otherwise howsoever; (iii) the Video shall not expose the Company and/or the Production House to civil and/or criminal proceedings and /or claims of any nature whatsoever; (iv) the Video is not subject to any lien, charge, or any other encumbrance whatsoever; (v) the Participant has not granted any rights in the Video to the prejudice of any rights granted to the Company hereunder; (vi) the Video is not violative of or in contravention of any applicable laws; (vii) all necessary licenses and permissions required for the utilization of the Video for the purpose of the Auditions have been secured by the Participant(s) in accordance with the existing Terms and Conditions and applicable laws without any recourse to the Company. In the event the publishing of the Video is assessed to be prohibited in any manner and/or considered to be inappropriate due to moral, political or religious reasons or any reason whatsoever, the Company and/or Production House shall have the right at its sole discretion to edit/ remove/cut the contentious portion and re-publish such Video or reject the Video

- altogether and the Participant agrees not to object to the same. The Participant(s) must ensure that no false and/or misleading statements are made by him/her and that he/she does not refer to any commercial product and/or service in the Video(s). The Participant further agrees and confirms that the Company is entitled to reject the Entry of the Participant in the event that the details submitted by the Participant at the time of registration are deficient, incorrect, untrue, or found wanting in any respect.
- vi. The Participant agrees and undertakes that the Entry/Video submitted by him /her is in good taste, and is not obscene, vulgar, abusive, hateful, libelous, defamatory, insulting, annoying, or otherwise inappropriate etc.
 - vii. The Participant(s) further agree and undertake that he /she shall not host, display, upload, modify, publish, transmit, update, submit, share the Video(s) and/or information that:
 - a. belong to another person and to which the Participant(s) do not have any right;
 - b. is grossly harmful, harassing, blasphemous, hurts religious or community sentiments pornographic, paedophilic, invasive of another's privacy, hateful, or racially, ethnically objectionable, disparaging, promotes illegal activities or violence including but not limited to money laundering or gambling, contains false or misleading information or otherwise unlawful in any manner whatever;
 - c. harm minors in any way;
 - d. infringes any patent, trademark, copyright or other proprietary rights;
 - e. violates any law for the time being in force;
 - f. deceives or misleads the addressee about the origin of such messages or communicates any information which is grossly offensive or menacing in nature;
 - g. impersonates another person;
 - h. contains software viruses, Trojans, spyware, malware or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer resource, including harming recipient's computers/system/servers etc.;
 - i. threatens the unity, integrity, defence, security or sovereignty of India, friendly relations with foreign states, or public order or causes incitement to the commission of any cognisable offence or prevents investigation of any offence or is insulting any other nation.

For avoidance of doubt, Participant agrees that the Company has the right to remove any such material/Entry which breaches any of the terms of these Terms and Conditions and the Participant shall not be entitled to object to the same.
 - viii. For purposes of the Auditions, logging onto the Website, furnishing the Personal Information in the mode and manner as prescribed, under the registration form mandatorily uploading 1 (one) Video shall be considered as a complete and valid entry ("**Entry**" or "**Entries**"). It may be clarified that once the video is uploaded on the Website, he/she shall not be entitled to re-submit any information, including but not limited to any Video and such Entry submitted by him/her shall be considered final and valid Entry for the purpose of the Audition. Any incomplete Entry will be disqualified and will be considered as null and void. For avoidance of doubt, if the Participant(s) fails to provide upload the video or provides a fake email ID or fails to furnish Personal Information in the manner prescribed or if the Video submitted is more than the maximum duration stated herein, then his/her Entry shall be considered incomplete and the Participant(s) shall be disqualified from participating further in the Auditions. The Channel/Company and/or Production House shall be free at any point of time to contact and /or communicate with the Participant(s) for availing any additional information and/or to verify any details as provided in relation to Auditions and/or the Entry and the Participant(s) shall unconditionally facilitate the same. Any incomplete Entry and /or Entries with incorrect format, broken/bad web link, inadequate Personal Information, invalid email ID, invalid mobile number or which consist of content, which contains any of the elements specified in the above

sub-clause, will be considered invalid, shall be considered null and void and will be disqualified from participating in the Auditions.

- ix. Entries received after the Audition Period will not be considered for the Auditions and shall be deemed null and void. The Company and/or Production House shall not be responsible for any Entries submitted, whether correctly or not, but not received due to any reason whatsoever. It shall be the sole responsibility of the Participant(s) to ensure that the Entry is submitted correctly after following the due procedure specified by the Company hereunder and Terms and Conditions prescribed herein.
- 6. At each Level of Auditions, the selected Participants shall be intimated by the Company and/or the Production House about his/her selection to further Level(s) and the procedure for participating in the next Level. In case the Participant(s) are unable to participate / attend in the respective further Levels, on the scheduled dates and time as communicated by the Company and/or the Production House for any reason whatsoever, he/she will be disqualified from participating in respective further Levels of Auditions and the decision of the Company and/or Production House in this regard shall be considered final and binding and the Participant(s) shall not challenge /dispute such decisions.
 - 7. Participant(s) undertake that all Personal Information, contents of the registration form provided by him/her at the time of registration are true, correct and accurate. Any incomplete entry(ies) with incorrect format/information and/or inadequate information will be considered invalid and will be disqualified from participating in the Auditions. The Channel/Company and/or Production House shall be free at any point of time to contact and/or communicate with the Participant(s) for availing any additional information and/or to verify any details as provided in relation to the Auditions and the Participant(s) shall unconditionally facilitate the same.
 - 8. The selection and shortlisting process for the Auditions shall be conducted as detailed below for each Level of the Auditions.
For the sake of clarity, Participant cannot enter the Auditions without undergoing the process at each Level:

A. LEVEL 1

- i. Subject to the Participant(s) having made a valid Entry, all the Video(s) fulfilling the criteria set out herein shall be viewed and evaluated by the Production House and/or the Company and/or its representatives and/or professional experts appointed by the Company and/or the Production House, at their own discretion (“**Panel**”). The decision of the Company with regard to the composition of the Panel shall be final and binding on the Participant(s). Participant(s) shall not be entitled to dispute and/or challenge the composition or the decision of the Panel at any time in connection with the selection procedure, to the maximum extent permitted by law.
- ii. The Participant(s) shall be evaluated and shortlisted by the Panel on the overall basis of his/her Entry, Video, eligibility, confidence level, profile, voice quality, grace, strong & distinct personality, uniqueness, screen presence, articulation, entertainment quotient, conflict potential, self-awareness, personality to challenge celebrity contestants, fearlessness etc., or any such other criteria determined by the Company/Production House at its sole discretion.
- iii. The Panel shall have the sole authority to judge and rate the Video(s) and profile and personal information of all the Participants and their decision shall be final and binding on all Participants. The timelines for such selection and intimation shall be at sole discretion of the

- Company and/or the Production House and the Participant shall not have any right to question for the same.
- iv. All the Participant(s) selected and shortlisted for Level 2 shall be intimated about the selection vide an email and/or personally intimate via telephone to the contact number that has been provided by the Participant at the time of registration or any other mode of communication as the Company and/or the Production House may deem fit at its sole discretion, and the Participant(s) shall be solely responsible for checking the emails and/or calls received from the Company and/or the Production House. If the communication is received through email, the Participant(s) shall within 24 (twenty-four) hours or receipt of such email confirm the participation of the Participation for next Level. If the communication is received through phone call, the Participants shall be required to give confirmation of the Participant's participation for Level 2 immediately against receiving the call. Such communication by the Company and/or Production House shall also give brief details of next Level of Auditions i.e. Level 2, date and time of the Auditions, etc. and requirements for the Level 2, which the Participant shall be required to confirm and make necessary arrangements for the same, prior to the Level 2. C. LEVEL 3

- i. Participant(s) shortlisted at Level 2 shall be required to be available for Level 3 Auditions, i.e for a personal interview at any locations across Kochi and /or Kerala as per the requirement and instructions of the Company and/or the Production House, determined at its sole discretion.

- This shall be informed by the Company and/or Production House to all the short-listed Participants well in advance, along with the details of Level 3 Auditions, such as the date, time and place and manner of conducting said Auditions.  - iii. In the Level 3, the shortlisted Participants of Level 2 shall be evaluated by the Panel on the basis of their personality, confidence, emotional range, relatability, mental and emotional resilience, trigger potential etc. and such other criteria as may be determined by the Company and/or the Production House in its sole discretion and if the Participant is shortlisted in Level 3, they shall be eligible for participation in Level 4.

For avoidance of doubt, it is clarified that it is not mandatory for the Company to publish and Exploit Videos/Recordings of all the Participants who has entered into this Level 3. No correspondence and/or phone calls shall be entertained in this regard.

D. LEVEL 4

- i. Participant(s) shortlisted at Level 3 shall be required to be available for Level 4 for a personal interview at any locations across Kochi and /or Kerala as per the requirement and instructions of the Company and/or the Production House, determined at its sole discretion. This shall be informed by the Company and/or Production House to all the short-listed Participants well in advance, along with the details of Level 4 of Auditions such as the date, time and place and manner of conducting Level 4 of Auditions. It shall be the sole responsibility of the Participant to make himself/herself available for such Level 4 Auditions. If the Participant fails to make himself/herself available for Level 4 Auditions on the date, time and place as informed by the Company and/or the Production House, the Entry of the Participant will be deemed invalid and the Participant shall not be eligible for the further Levels and shall consequently be disqualified and the Company shall be free to select any other deserving Participant at its own discretion.
- ii. The Company and/or Production House shall be free at any point of time to contact and /or communicate with the Participants for availing any additional information and/or to verify any details as provided in relation to Auditions and/or the Entry and the Participant shall unconditionally & promptly facilitate the same.
- iii. In the Level 4 of Auditions, the shortlisted Participants of Level 3 shall be required to participate in a personal interview with other Participants and the same shall be evaluated by the Panel on the basis of their emotional intelligence, psychological stability, sociability, group dynamic, contradiction or complexity of character etc. and such other criteria as may be determined by the Company in its sole discretion, and if the Participant is shortlisted in the Level 4 Auditions, they shall be eligible for participation in Level 5 of the Auditions.

- vii. All the Participant(s) selected and shortlisted for Level 5 shall be intimated about the selection vide an email and/or personally intimate via telephone to the contact number that has been provided by the Participant at the time of registration or any other mode of communication as the Company and/or the Production House may deem fit at its sole discretion, and the Participant(s) shall be solely responsible for checking the emails and/or calls received from the Company and/or the Production House. If the communication is received through email, the Participant(s) shall within 24 (twenty-four) hours or receipt of such email confirm the participation of the Participation for next Level. If the communication is received through

phone call, the Participants shall be required to give confirmation of the Participant's participation for next Level immediately against receiving the call. Such communication by the Company and/or Production House shall also give brief details of next Level of Auditions i.e. Level, date, time and place of the Auditions, etc. and the Participant shall be required to confirm and make necessary arrangements and participate for Level 5 of Auditions. It is clarified that in the event the Participants have not appeared/participated in the Level 4 Auditions, they shall not be eligible for further Levels and shall consequently be disqualified and the Company and/or the Production House shall be free to select any other deserving Participant at its own discretion.

E. LEVEL 5

- i. All the Participant(s) selected and shortlisted for Level 5 shall be intimated about the selection vide an email and/or personally intimate via telephone to the contact number that has been provided by the Participant at the time of registration or any other mode of communication as the Company and/or the Production House may deem fit at its sole discretion. Such communication by the Company and/or Production House shall also give brief details of Level 5, date, time and place etc. and the Participant(s) shall be required to, as part of the Auditions, appear and participate in the Program. Level 5 shall be telecasted on the Channel (as defined above) for audiences who shall be voting to for the Commoner Contestant(s) who shall have the opportunity to participate in the Program. It is clarified that in the event the Participant(s) have not appeared/participated in the Level 5, they shall not be eligible for final selection and shall consequently be disqualified and the Company and/or the Production House shall be free to select any other deserving Participant at its own discretion.
- ii. The Participants shall be required to sign and execute the Declaration cum Indemnity and/or any other document as may be required by the Company for participating in the Level 5.
- iii. The recordings of Level 5 of the Auditions shall be compiled into a program tentatively titled **"Bigg Boss Agnipareeksha"**, comprising 21 (twenty-one) episodes or such other number of episodes as may be determined by the Company at its sole discretion (**"Bigg Boss Agnipareeksha Series"**). The Bigg Boss Agnipareeksha Series shall be published, communicated to the public and otherwise Exploited on the Company's Channel (as defined above).
- iv. In the Level 5 of Auditions, the shortlisted Participants of Level 4 shall be evaluated by the panel consisting of previous contestants who were a part of the old seasons of the Program and/or individuals identified and selected by the Company and/or the Production, (**"Jury"**) on the basis of their communication skills, ability to hold attention, strategic mindset, physical energy etc. and such other criteria as may be determined by the Company and/or Production House.
- v. - vi. The final selection of the Commoner Contestant(s) shall be conducted on the basis of: (a) the voting mechanism by the viewers which shall conducted by the Company and/or Production House; and (b) the evaluation undertaken by the Jury. Basis the combined outcome of the aforesaid criteria, the Participant(s) who have garnered the highest votes/scores as per the criteria finalized by the Company and/or Production House, shall be selected as the Commoner Contestant(s). It is clarified that the Company shall at its sole discretion finalize the voting mechanism for the voting and selection of the Commoner Contestant(s) and publish

- the same and details pertaining to it on the Microsite / digital platform /Website or any other medium in any manner as deemed fit by the Company. Neither the Participant(s) nor viewers can raise any objection or make any claims in this respect against the Company and/or the Production House. Further the Participant(s) and /or viewers shall be liable to check the Microsite and /or digital platform /Website for more details on such voting mechanism.
- vii. Only 05 (five) Participant(s) or such other number as decided at the sole discretion of the Company shall be selected and eligible as the Commoner Contestant(s) who shall then be given the opportunity to participate in the Program.
 - viii. The timelines for publishing and Exploitation of such Bigg Boss - Agnipareeksha Series shall be at the sole discretion of the Company and/or the Production House and the Participant(s) shall not have any right to question for the same.
 - ix. The Company and/or Production House shall be free at any point of time to contact and /or communicate with the Participant(s) for availing any additional information and/or to verify any details as provided in relation to Auditions and/or the Entry and the Participant(s) shall unconditionally & promptly facilitate the same.
 - x. The Participant(s) selected in this Level as Commoner Contestant(s) shall be personally intimated about his/her selection vide an email and/or telephone or any other mode of communication, as the Company may deem fit at its sole discretion, and the Participant(s) shall be solely responsible for checking the email /calls received from the Company.
 - xi. The timelines for such intimation shall be at the sole discretion of the Company and/or the Production House and the Participant shall not have any right to question for the same.
 - xii. The selected Commoner Contestant(s) shall have to ensure that he/she will make himself/herself available for all shoot dates and travel to any place for the shoot of the Program, as may be informed by the Company and/or Production House from time to time.
 - xiii. In the event of the failure of the Commoner Contestant(s) from attending the Studio within the aforesaid timelines for any reason whatsoever the Company shall at its own discretion be entitled to exclude/disqualify such Participant from the Program and the Company shall be free to select any next deserving Participant basis the voting mechanism or such other mechanism at its sole discretion.
 - xiv. In the event of any misconduct/misbehaviour of the Participant(s) during the participation in Level 5 Audition, such Participant(s) shall not be eligible as a Commoner Contestant(s), even if qualified in the voting and he/she shall be deemed to be rejected or disqualified to enter into the Program. Such decision shall be final and binding on the Participant(s).
 - xv. Such selected Commoner Contestant(s) shall be required to mandatorily attend the orientation / training sessions /workshops conducted by the Company at such time and place as the Company may deem fit.
 - xvi. The Company and/or Production House reserves the right to introduce other prospective shortlisted contestants who have gone through the similar selection process or such other selection process as deemed fit by the Company and/or Production House, at any Level of the Auditions to qualify as the Commoner Contestant(s) Such decision of the Company and/or the Production House shall be final and binding upon all the Contestants.
 - xvii. The Commoner Contestant(s) shall be required to sign and execute the Participation Agreement and/or any other document as may be required to be submitted by them on the registration form in a manner and form, as requested and /or prescribed therein ("**Participation Agreement**") within 24 (twenty-four) hours from the date of receipt of the Participation Agreement.
9. The Participant(s) will be solely responsible to bear all costs of travel, accommodation and all other expenses, should such Participants voluntarily wish to participate in the Auditions during the Audition Period without any recourse to the Company and/or the Production House. The Company and/or Production House will not entertain any such requests for logistical or other related issues.

10. The Participant(s) shall maintain the decorum of the Audition Centre(s) and shall abide by the rules and regulations thereof. Further the instructions of the Company and/or the Production House shall be adhered to strictly. Any Participant who acts in contravention to the instructions of Company and/or the Production House or creates nuisance in any manner shall immediately be disqualified from participating in further Levels of Auditions and/or shall not be eligible to become a Commoner Contestant, even if qualified in Level 5.
11. The Participant(s) will be required to execute any and all legal documents including but not limited to Participant Agreements, as required by the Company including but not limited to submitting all the necessary information (in addition to the information already submitted at Level 1 and/or Level 2 and/or Level 3 and/or Level 4 and/or Level 5 if any) and also furnish the documents as sought and as required by the Company and/or the Production House from time to time, to verify the Personal Information provided by the Participant(s) in Level 1, Level 2, Level 3, Level 4 and Level 5. For avoidance of doubt it is clarified that each of the selected Participant(s) shall be required to furnish the necessary documentation (as stated in the General Rules below) in original to confirm the eligibility details, etc. In case the Participant is unable to furnish the original document(s) to verify the eligibility details and also fails to submit self-affirmed photocopy of the same, the said Participant(s) shall be disqualified from the Auditions, based on the sole discretion of the Company and/or the Production House.
12. Participant(s) who have previously participated in any similar reality shows/programs and/or appeared/featured in any television programs (of any genre) or has entered into any contract or contractual arrangement including but not limited to having signed any document or letter in respect of any such participation/appearance with any third party/persons including but not limited to media companies, production houses, broadcasting companies, agencies in relation to participation in such reality shows or featuring and /or appearance, will need to mandatorily disclose the details of such prior participation. Company reserves the right to disqualify such Participant(s) on such ground, based at its sole discretion. The Participant(s) agree to fully co-operate with the Company for any additional information that may be required by the Company to evaluate the facts related to the matter.
13. For avoidance of doubt it is clarified that the final selection of the Commoner Contestant(s) by the Company shall be final and binding on all the Participant(s) and in no event shall the Participant(s) dispute the decision made by the Channel/Company and/or Production House or its employees in connection to the Auditions. For the sake of clarity, in the event of any fault, misunderstanding or dispute concerning any part of the Auditions and/or the selection process to qualify for the Program, the decision of the Company shall be final and binding.

GENERAL RULES

1. The Auditions is strictly open to Participant(s) who has attained 18 (eighteen) years of age on or before 01st June, 2026, and is an Indian citizen and residing in India during the Audition Period and the for the duration of the Program, as per the respective applicable laws of India and is able to speak fluently in Malayalam language.
2. Employees of the Company, of the Production House, the advertising agency or any other agency or third-party vendor which has been appointed from time to time, and also employees of the main sponsors and members of their immediate family; are ineligible to participate in the Auditions. Further, failure to provide proof or affidavit of eligibility, including the correct date of birth, nationality including any of the documentation required under these Terms and Conditions, within the timelines specified by the Company hereunder may result in disqualification. The Company also reserves the right to disqualify the Participant(s) in case discrepancy is found to exist in the

information furnished/provided/stated by the Participant(s) during the conversation with the Company and in the information(s) stated in the documents furnished by the Participant(s).

3. In the event the Participant(s) is found to be in violation of any applicable laws at any point of time during the Auditions, the Company reserves the right to disqualify the Participant immediately and his /her Entry shall be considered null and void. Such disqualified Participant shall not be eligible to proceed further in the Auditions.
4. Participant(s) represent to the Company and/or Production House that the Participant(s) is free and competent to enter the Auditions; is the sole, absolute, unencumbered legal and beneficial owner of all rights granted to Company and/or Production House respect of the Materials, is not under any disability, restriction or prohibition, whether legal, contractual, physical, mental, medical or otherwise, which might prevent the Participant from performing or observing any of the obligations undertaken or from honoring any of the Terms and Conditions stated herein.
5. Participant(s) hereby provides his/her consent for collection, receipt, storage, use, transfer and retention of Personal Information, which is subject to: (i) the Privacy Policy, and (ii) the following terms and conditions:
 - a. The Participant has read, understood and accepted the Privacy Policy and understand and agree that the Personal Information is subject to the terms of this Terms and Conditions and the Privacy Policy.
 - b. The Personal Information may include information *inter alia* name, date of birth, address, age, gender, place of birth, contact details, photograph, language spoken, citizenship/nationality, residence, government identity proof, hobbies, physical, physiological, mental health condition, images, videos etc. of the Participant and may also include name, nationality, contact details, emergency contact number, email ID etc. of the Participant(s).
 - c.  - i. The Company has provided the Participant(s) with the option to opt out of providing his/her Personal Information and the Participant(s) has not exercised such option.
6. The Participant(s) shall not make any claims against the Company and/or the Production House, their directors, employees arising out of or relating to any and all costs, injuries, losses or damages of any kind, including, without limitation due to any technical faults or directly or indirectly, to their participation or non-participation in the Auditions/Bigg Boss – Agnipareeksha Series or any related activity including any unauthorized access of the Videos, etc. If the Participant is found to be ineligible, or if the Participant(s) has not complied with these Terms and Conditions, Terms of Use, Privacy Policy and/or User Generated Content the corresponding Entries will be disqualified.

 10. The Company reserves all rights to make amendments to the Auditions Period, Levels of Auditions or such other terms and conditions stated herein, without giving prior notice. It shall be the sole responsibility of the Participant(s) to check the Terms and Conditions for the Auditions on the Website

and /or the platforms from time to time. Company and/or the Production House also reserves the right to evade/skip any type and/or Levels of Auditions, reserve the right to include new Levels or alter the existing Levels and also reserve the right to cancel and/or postpone the Auditions and/or Bigg Boss – Agnipareeksha Series and/Program at any point of time without any prior intimation to the Participant.

11. 17. In case for whatever reason any Participant(s) is not agreeable to travel, stay, *etc.* entirely at his/her own expense, the Company and/or the Production House will regretfully consider the Entry/On Ground Entry of such Participant(s) as invalid and the Participant(s) shall be disqualified.
18. In the event of any fault, misunderstanding or dispute concerning any part of the Auditions/ Program and/or the selection process to qualify for the Program, the decision of the Company shall be final and binding and each Participant(s) shall without limitation be bound by such decision of the Company.

22. Non-conformance by any Participant directions/instructions issued by the Company, Terms of Use, User Generated Content, or Privacy Policy then Company will at its sole discretion be entitled to disqualify their Entry on an immediate basis.
23. Participant(s) specifically agree, allows, grants and permits the Company or any party authorized by it to record (audio-video/audio or video), the participation process/performance at every level of the Audition, including any interaction of the Participant with the Company or fellow Participant or any representative of the Company, if any, of the Participant(s) rendered during the Auditions or Bigg Boss – Agnipareeksha Series or the Program or any related series of sound recordings and video recordings which have been shot/filmed/recorded during the Auditions or the Program on film, tape or digital or other electronic media and includes recording of any personal questions or conversations relating to the personal lives of the Participant (“**Footage**”) and agree that the Footage may be used by the Company as it deems fit anywhere in the world at any time now or in the future, including but not limited for promotion of the Program. For the avoidance of doubt, all rights in the Footage vests exclusively with the Company worldwide in perpetuity and the Company is entitled to exploit the same in any manner it may deem fit.

26. In consideration of being afforded an opportunity to participate in the Bigg Boss – Agnipareeksha Series /Program/Auditions, the Participant(s) agree, represent and warrant that all Intellectual Property in and to the Materials shall remain the exclusive property of Company from the moment they arise, for the entire period of their subsistence, in every part of the world. To the extent, that the Intellectual Property or any rights, title and interest in the Materials, do not vest with Company, by operation of law, the Participant(s), on an outright basis hereby irrevocably, exclusively, perpetually and for the entire world assigns and transfers all Intellectual Property vested in the Materials including rights in any Exploitation thereof to Company. To the extent that the assignment of rights, title and interest in the Intellectual Property in and to the Materials in relation to future medium or mode of exploitation of the Materials is not held valid by operation of law, notwithstanding the assignment of such rights in favor of Company, the Participant(s) hereby grant an irrevocable, exclusive, sub-licensable, perpetual license to Company for such future medium or mode of exploitation of the Intellectual Property in and to the Materials as may be developed in the future, for the entire world. Notwithstanding the above, the Participants hereby agree that they shall not assign or in any other manner transfer rights including the Intellectual Property in and to the Materials for such means and modes of exploitation of the Materials which are not mentioned herein and are not presently known or in commercial use and therefore by operation of law are not deemed to have been assigned to Company without offering for assignment such modes or means of exploitation of the rights including Intellectual Property in and to the Materials for the entire world and perpetuity to the Company. The Participant(s) agrees and acknowledges that any form of assignment or transfer of any rights, title and interest in any such future modes and mean of exploitation of the Intellectual property in and to the Materials to any third party in breach of the obligation herein, anywhere in the world shall be null and void. Further, Company may Exploit the rights including the Intellectual Property in and to the Materials at any time it chooses, and it is expressly agreed by the parties that Section 19(4) of the Indian Copyright Act, 1957 will not apply to this Terms and Conditions.
27. The Participant(s) waive off their “Moral Rights” with respect to the Materials/ participation in the Auditions/ Program/Bigg Boss-Agnipareeksha Series. Further, the Participant(s) agree and acknowledge that they shall not be entitled to any share in the revenues arising from exploitation of the Materials. The Participant acknowledges that the Entry/On Ground Entry submitted and /or Videos submitted and/or contribution to the Materials does not qualify as a ‘performance’/ ‘live performance’ within the meaning of the Indian Copyright Act, 1957.
28. The Participant(s) agrees and acknowledges that the Channel /Company shall have the sole and exclusive right to edit, alter, modify and or use any Footage or Materials in respect of their Entry uploaded on the Platform or any such Footages in any manner whatsoever it may deem fit and necessary at its sole discretion (including but not limited to as a part of the Bigg Boss – Agnipareeksha Series /Program/Auditions or any ancillary event related to the Bigg Boss – Agnipareeksha Series /Program/Auditions etc).
29. The Participant(s) shall make themselves available from time to time and co-operate with the Channel and/or Company and/or Production House and participate in any activity and/or campaign and /or events (“**Promotional Activity**”) of any nature whatsoever with respect to the Bigg Boss – Agnipareeksha Series /Program/Auditions without any money payable/ any consideration to the Participant. Further, the Participant shall at no point of time refuse or disagree for participation of the Participant(s) in any such Promotional Activity for any reason whatsoever.
30. Participant(s) hereby allow the use of the face, image, biographical data, name, signature, voice, photographs of the Participant and the family/relatives/friends/colleagues of the Participant (**‘Likeness’**) to appear on and be used in connection with the promotion of the Bigg Boss – Agnipareeksha Series /Program for all media, all means of exploitations, distribution including, but not

limited to, the press, internet, television. Company reserves the right to use, in any manner whatsoever, in part or in whole the Likeness, Bigg Boss-Agnipareeksha Series, Program and/or program elements including without limitation in connection with any merchandise, tie-in, product or service of any kind, whether or not such use is in connection with the Program or Bigg Boss – Agnipareeksha Series or Company or the Channel without notice to the Participant and without any further compensation to the Participant(s).

31. The Participant(s) agree that in consideration of being given opportunity to the Participant to participate in the Auditions, they shall hold harmless the main sponsor (if any), Channel, Company, Production House, its employees, officers, directors, affiliates, group companies or any other person from and against any injury/damage/harm/loss/ death/ mental or emotional trauma suffered by the Participant, in any manner whatsoever in connection with the Auditions and /or Entry and /or any aspect related to their participation in the Auditions and to the extent permissible under law waives all rights to file in person/ through any family member and/or third party any applications, criminal and/or civil proceedings in any courts or forum in India against the Production House and/or the Channel and/or Company to claim any damages or reliefs or otherwise.
32. The Participant(s) agree to keep the Company, the Channel, Production House, its employees, officers or any other person indemnified from and against any claims or demands, cause of action, judgments, liabilities, losses, costs and expenses that may arise out of a result of any violation of any third party rights/material in with respect to the Exploitation of the Entry including the Video, Recordings, by the Company and /or any of its affiliate companies and/or channels.
33. The Participant agrees that the Company and/or Production House shall in no event, whatsoever, be responsible for any medical or other problems suffered by the Participant during or in relation to their participation in the Auditions including but not limited to travelling anywhere and anytime and undertake the performances required for the Program. The Participant(s) acknowledges and understands that the participation in the Auditions is at their own risk. The Company and/or the Production House shall not be responsible for the Participant's safety during the Auditions, nor shall they be required to obtain any insurance in relation to the same for the Participant. The Participant(s) acknowledge and understand that the participation of the Participant in the Auditions/Program/ Bigg Boss – Agnipareeksha Series is at his/her own risk.
34. Certain information relating to the Production House, the Company, the Program, Bigg Boss-Agnipareeksha Series, Channel, will be disclosed to the Participant(s) by the Production House and/or the Company which is confidential and/or proprietary in nature, and includes data, the format of the Program, Bigg Boss-Agnipareeksha Series, the manner of selection/elimination etc., whether or not explicitly designated as "confidential", disclosed or to be disclosed (including information transmitted in written, electronic, magnetic or other form and also information transmitted orally, visually or by other means) and any and all information which may be developed or created, in whole or in part, directly or indirectly, from such information (altogether, "**Confidential Information**"). Participant(s) agree that Confidential Information whether disclosed orally or in writing, is the property of Production House/the Company, as the case may be, and is valuable, special and unique to the business of Production House/the Company, as the case may be. Participant(s) agree that the Participant shall not discuss and/or disclose any information about the Program, the performances of other participants in the Program with any third party; and also not disclose the names of the participants eliminated in respective rounds of eliminations in the Program/Auditions.
35. Participant(s) shall not engage in any activity that would in any manner result in violation of any applicable anti-bribery or anti-corruption laws applicable to the parties hereto.

36. The Participant(s) acknowledges that in case any portion/clause of these Terms and Conditions is deemed invalid or becomes unenforceable or prohibited by the law of the country, such portions shall be considered divisible and shall not be part of the consideration, and the remainder of these Terms and Conditions shall be valid and binding and of like effect as though such provision was not included herein.
37. Participant(s) acknowledges that their representations, warranties, indemnities, grant of rights in the Entry including Materials, Promotional Activity, dispute mechanism and obligations shall survive the efflux of time and the termination of these Terms and Conditions.
38. The participation of the Participant in the Auditions shall mean that the Participant has read, understood, accepted and agrees to unconditionally abide with all the rules including the General Rules of the Auditions, Terms and Conditions, the Privacy Policy, other Policies, including Website Terms of Use and Governance as provided on the Website.
39. Notwithstanding the conflict of laws principle, these Terms and Conditions shall be construed in accordance with the laws of India and in case of any dispute or other matter arising in reference to the Auditions and /or Entry and/or the Program, shall be referred to a sole arbitrator appointed by the Company and shall be governed by the Arbitration and Conciliation Act, 1996, amended from time to time. The venue for arbitration shall be Kochi (India), in English language. All the costs, charges and expenses in connection to the Arbitration shall be solely borne by the Participant(s) who has raised the dispute.
40. Subject to the provision of 38 above, the Courts having exclusive jurisdiction under the provisions of the Arbitration and Conciliation Act, 1996, to determine all matters which the Court is entitled to determine under the Act, including, without limitation, provision of interim relief's under the provisions of Section 9 of the Arbitration and Conciliation Act, 1996, shall exclusively be the courts at Kochi, India. The Participant(s) agrees to exclusively submit to the jurisdiction of the Courts and dispute resolution mechanism as set out herein.
