

TERMS AND CONDITIONS

Please read these terms and conditions (“**Terms**”) before submitting your Entry (as defined below) for the potential selection of participants for the upcoming Tadka reality show tentatively titled ‘**Rizzmaster**’ (“**Program**”) being produced for JioStar India Private Limited (*formerly known as Star India Private Limited*) (“**Company**”) by **Rusk Distribution Pvt. Ltd.** (“**Production House**”). The details of the Program’s shooting schedule shall be made available to the shortlisted or selected Submitters (as defined below), by the Company or Production House, to the extent required for the relevant Submitters’ participation in the Program.

These Terms shall be irrevocably binding on each person voluntarily submitting their Entry (as defined below) for their potential selection as a participant in the Program (“**Submitter**”). The Privacy Policy (as defined below) shall govern all usage of any Personal Information (as defined below) and/or any other information as detailed in the Privacy Policy, including but not limited to the name, age, email address, mobile phone number, government ID, social media ID/handles, video(s) and/or any information gathered by the Company under or pursuant to the Entry and/or participation in the Program. By submitting your Entry, you hereby consent to the collection, storage, disclosure, processing, transfer of and sharing of the Personal Information by the Company, the Production House, its affiliates and designated third parties in accordance with the terms of its Privacy Policy, as may be amended from time to time, and which is accessible at <https://www.hotstar.com/privacy-policy/in> (“**Privacy Policy**”). The Submitter’s act of submission of the Entry shall be deemed to be the Submitter’s absolute acceptance and agreement to the Terms and the Privacy Policy.

1. **Eligibility:**

- a) Submission of the Entry is open to only to individual males who are adults 18 (eighteen) years and above and are resident Indian citizens.
- b) The Submitter must not have been convicted of any offense involving fraud, moral turpitude or crimes against any person, nor must otherwise be legally prohibited from submitting their Entry and/or participating in the Program, if selected.
- c) The Submitter should have proof of age, citizenship and residency when requested by the Company and/or the Production House and must be mandatorily submitted by the Participant upon the Company/Production House’s request, to confirm the eligibility of the Submitter. Failure to provide any such proof shall result in instant ineligibility.
- d) The Submitter should always abide by all the applicable laws.
- e) Employees, affiliates, directors, representatives, consultants and contractors of the Company, Production House and their immediate family member(s) (being a spouse, partner, parent, sibling or child) are not eligible to be shortlisted or selected for participation in the Program and therefore should avoid submitting any Entry(ies).

2. **Submission Period:** The portal for submission of Entries shall be open and valid from 17th July 2026 and shall remain valid until such time as Company may declare, including by way of promotional or social media communications (“**Submission Period**”). The Company may alter the duration of the Submission Period at its sole and absolute discretion. It shall be the sole responsibility of the Submitter to stay updated with these Terms and to submit the Entry during the Submission Period.

3. **Submission Mechanism:**

- a) To be eligible to participate in the Program, the Submitter must fully and accurately fill, complete and submit the official online form (“**Form**”) made available at (“**Portal**”). As a part of the Form, *inter alia*, the Submitter must upload an audio-visual clip, in vertical orientation, in response to the relevant question in the Form (“**Content**”) (collectively, the “**Entry**”). For the avoidance of doubt, it is clarified that the Content should only feature you, and should only include details about you, that you are comfortable sharing knowing that the Content may be made publicly available.
- b) By submitting the Entry and the Content on the Portal you: (i) agree with the Terms as defined herein; and (ii) grant the Company and the Production House a non-exclusive license to use your Content, Entry in its entirety or any part thereof, worldwide and in perpetuity for inclusion in the Program or any related content/materials, the promotion of Program across all modes, media and mediums, without any payment being due to you or any third-party for such use.
- c) The Content should:

- i. be taken via mobile phones and/or tablets;
 - ii. be in portrait mode;
 - iii. be audible, having a good audio/sound quality;
 - iv. be taken through the default camera application of the mobile phone and/or tablet;
 - v. be visually clear, well-lit and should not be pixelated or distorted and should be taken on 'HD' or 'High Definition' mode;
 - vi. not be shaky/unstable;
 - vii. have a buffer of 1 (one) to 3 (three) seconds at the beginning and end;
 - viii. be of a duration of 60 (sixty) seconds exactly;
 - ix. be shot against a clean and uncluttered background;
 - x. feature only you, and you should be appropriately dressed, without any obscenity or revealing clothes;
 - xi. be shot in the premises of your house, connected areas or private spaces and not shot in any public spaces;
 - xii. not contain any weapons or objects of religious/national importance (Indian National Flag, National Emblem, Religious Imagery etc.);
 - xiii. not contain any watermarks or logos, filters or other artificial enhancements/modifications and should be free and clean of any product placement or brand integration or endorsement;
 - xiv. not be edited using any film making effects (lapse photography, slow motion, half speed, etc.);
 - xv. be shot in a way to ensure that your face is always visible and you can be easily identified; and
 - xvi. comply and be in accordance with guidelines set out in these Terms and the Portal.
- d) If the Content does not meet the above criteria the Company reserves the right to reject the Entry and disqualify the Submitter. The Company also reserves the right to reject an Entry and disqualify the Submitter as per any other conditions or parameters as determined by the Company at its sole discretion. The decision of the Company for all matters relating to rejection of an Entry and/or disqualification of the Submitter shall be final and binding in all respects.
- e) The Company and the Production House shall not be liable for any injury, illness, damage, loss, accident, expense, or any other claim arising from or in relation to the submission of the Entry.
- f) After reviewing the Entry and the Content therein, the Company at its sole discretion shall shortlist Submitters ("Participants") for participation in the Program. Selection or rejection of the Submitter shall be at the Company's sole discretion. The Company and/or Production House will inform shortlisted/selected Submitters of their shortlist/submission by contacting the relevant Submitter(s) at the contact details provided as a part of the Entry. The Production House and/or the Company shall make only one (1) attempt to reach any Submitter. In case they do not revert within the timeline specified in the Production House or the Company's communication to such Submitter, the shortlist/selection shall be invalidated, and the Production House and/or the Company shall not be liable to such Submitter in any manner whatsoever.
4. **Representation and Warranties of the Submitter:** You hereby represent warrant and undertake that:
- a) you are not under any disability, whether legal, contractual or otherwise, which prevents you from submitting the Entry, participating in the Program and or accepting these Terms;
 - b) if and when participating in the Program you shall at all times comply with the applicable laws and conduct yourself in a professional and decent manner;
 - c) the Entry and/or Content shall be original and by the Submitter alone in his individual capacity and should not infringe and/or violate any third party's rights, including intellectual property rights, moral rights, privacy/personality rights;
 - d) you have the necessary releases and permissions as required, without the need for payment to any other person or entity, to use and exploit, and to authorize the Company to use the Content in all manners contemplated by these Terms. You further undertake that the Content does not contain any third-party copyrighted audio-visual material, audio materials, musical works, literary works, without an explicit, valid, fully paid commercial license;
 - e) the Entry and/or the Content is/are completely free of any liens, charges, claims of any nature and/or any other encumbrances of any sort by a third party;
 - f) the Entry and/or the Content should not contain any text, or any content that promotes commercial products and/or services of any third party and does not contain any commercial third-party logos including that of the brand, products or brand names;
 - g) the Entry and/or the Content does not contain any personally identifiable information, image(s), or video(s) of any other person, confidential information relating to any third party/ies and/or any information relating to a

- third party which you are not lawfully authorized to disclose whether under a contractual obligation with a third party and/or under applicable laws anywhere across the world;
- h) the Entry and/or the Content should be in good taste and not be untrue, false, misleading, discriminatory, fraudulent, pornographic, unlawful, profane, obscene, vulgar, libelous, blasphemous, derogatory, defamatory, insulting, hurting religious sentiments, national sentiments, immoral, abusive, offensive, insensitive to any person/occupation/religious sections/gender/age group/sections of the society, in violation of any applicable laws;
 - i) the Entry and/or the Content should not contain software viruses, Trojans, spyware, malware or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer resource, including harming recipient's computers/system/servers, etc.; and
 - j) you may submit only 1 (one) Entry during the Submission Period and if multiple Entries are submitted, then only the first Entry will be considered for the purpose of these Terms.

The Company may, at its sole discretion, reject any Entry or disqualify any Submitter if he breaches this clause.

5. Selection for attending and participating in the Program:

- a) The selection and/or shortlisting of Participants for the Program shall be at the sole and absolute discretion of the Company. The Company has no legal or operational obligation to disclose individual scores, selection criteria, rejection rationales, or internal feedback to any Submitter. All decisions made by the Company regarding eligibility, screening, evaluation and final selection are final, absolute, and binding. No correspondence, appeals, or legal challenges shall be entertained under any circumstances. The Company may, at its sole discretion, issue a general status update or regret communication to the Submitters.
- b) Only selected Participants shall be given an opportunity to participate in the Program(s). The selected Participants are solely responsible for arranging and funding for their own travel, transit, lodging, accommodation, and incidental expenses required to participate in the Program. The Company and/or Production House shall not bear any financial liability or provide reimbursement for the same, unless otherwise communicated to the Participant in writing, by the Production House and/or the Company.
- c) The Participant understands and agrees that the Program shall be filmed, photographed, and recorded by the Production House on behalf of the Company. By participating in the Program, the Participant hereby grants the unconditional, perpetual, worldwide consent to the Company, the Production House and its authorized entities to record, photograph, store, broadcast, telecast and stream their appearance, name, voice, likeness, and interactions in any videos, corporate showreels, social media clips, or marketing campaigns, worldwide and in perpetuity, in any mode, mediums or formats (existing or future), without any entitlement to financial or other compensation.
- d) The Company reserves the right to change or withdraw the selection, at its sole discretion and at any time: (a) if the selected Participant fails to comply with any of the Terms and/or applicable laws; or (b) if any adverse findings about the Participant come to the Company and/or the Production House's knowledge.
- e) The right to participate in the Program is personal to the selected Participant and may not be assigned, transferred, or otherwise delegated to any other person or entity.

- 6. **Participant Information:** The Submitters and Participants hereby authorize and consent to the use of their respective personal or sensitive personal information, and personal data as applicable, ("**Data**") by the Company, the Production House, their affiliates, agents, advisors or subcontractors or any third-party service provider/s ("**Authorized Entities**"), for such lawful purposes as may be deemed necessary including for, producing the Program. The Submitter understands and acknowledges that (i) the Data is the Submitter's personal or sensitive personal information as understood within the meaning of the applicable laws; (ii) the Submitter has voluntarily and at the Submitter's sole option, agreed to provide the Data to the Authorized Entities for such lawful purposes as may be deemed necessary pursuant to these Terms; and (iii) the Data shall or may be transferred by the Authorized Entities, for such lawful purposes as may be deemed necessary pursuant to these Terms. The use of the Data by the Company shall be governed by the provisions of the Privacy Policy. The Participant agrees to be bound by the terms thereof. We may use third-party services to host the details pertaining to the submission of Entries. We recommend you review the privacy policy of such third-party service provider/s prior to providing the Data, as the third-party service provider may gain access to your Data.

The Submitters acknowledge and agree that they may be required to provide additional personal information (including without limitation government-issued IDs), if they are shortlisted or selected, for verification purposes. Any Submitter's selection/shortlisting will be subject to verification at the Company's discretion.

7. **Release:** You agree and acknowledge that:

- a) The promos for submission of Entries and the Program itself may be accessible to people who are below the age of 18 (eighteen) years, however, they are not the intended audience, and the call for Entries and the Program are only aimed at persons who have attained the age of majority in India.
- b) Where information is requested, the Submitter will provide true, accurate, current, and complete information about themselves.
- c) You acknowledge that Indian copyright law does not protect ideas, plots, or themes, and hence you waive any claims of copyright infringement or misappropriation based on coincidental similarities in case of any independent creation of similar works by the Company and/or the Production House.
- d) The Company, the Production House and any of their respective affiliates, directors, officers, professional advisors, employees and agencies shall not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions or entries; (b) electronic, hardware, software, network, internet, or other computer or communications-related malfunctions or failures; (c) any disruptions, injuries, losses or damages caused by events beyond the control of the Company; or (d) any printing or typographical errors in any materials associated with the call for Entries and/or the Program. The Company reserves the right to remove any Entry from the Portal or the Company's social media pages that the Company considers, in its sole discretion, to be off-topic, inappropriate or objectionable.
- e) Each Submitter hereby indemnifies the Company, the Production House and their affiliates, directors, officers, employees and agencies and hereby release them from any liability of whatsoever nature, and waive any and all causes of action, related to any claims, costs, injuries, losses, or damages of any kind arising out of or in connection with the Submitter's Entry and/or participation in the Program including but not limited to any violation of these Terms and/or any third party rights.
- f) Submission of the Entry does not guarantee selection for the purposes of participation in the Program and the decision in this regard shall at all times vest with the Company.
- g) Further, participation in the Program (if a Submitter is selected) does not guarantee (a) any improvement in the Submitter's personality, confidence levels or dating experiences, or (b) the Submitter's entry into a romantic commitment or relationship either during the course of the Program or at any time after.
- h) Participation in the Program, even till its very end, does not entitle any Participant to any gratification, whether monetary or otherwise. This sub-clause (h) is without prejudice to the Company's sole and absolute ability to control the direction and every other aspect of the Program, including with respect to the introduction of any additional elements (including gratification).

8. **Other Permissions:**

- a) The Submitter hereby grants the Company and the Production House, the non-exclusive right/permission to shortlist, edit, crop, overwrite, use, exploit, display, publish and/or utilize the Content, including through artificial intelligence or other automated tools (for example, AI-assisted editing, dubbing, translation or similar enhancement), in relation to the promotion of Program and inclusion of the Content in the Program, as they may deem fit at their sole discretion, on any/all modes, media and platforms.
- b) The Participants agree and have no objection to the Company's right to develop/modify/change and moderate the Content, creatively in any manner as deemed fit by the Company, either directly or through the Production House or any other service provider.
- c) The Submitter grants to the Company a non-exclusive, royalty-free and worldwide license under all applicable laws pertaining to copyright and other intellectual property right to use, reproduce, transmit, telecast, publicly display, exhibit, distribute, redistribute, copy, index, modify, adapt, create derivative works based upon, make available and otherwise exploit the Content, in whole or in part, on any service(s) and/or platform(s) owned and/or operated by the Company and on any social media platforms, in all media formats now known or hereafter invented, in any number of copies and without limit as to time, manner and frequency of use, without further notice to the Participant, with or without attribution, and without the requirement of permission from or payment to the Participant or any other person or entity, in accordance with these Terms.
- d) The Company reserves the right to stop any Submitter/Participant from participating in the Program if the Submitter/Participant is found to be in breach of any provisions of these Terms (as may be revised from time to

time). The decision of the Company in this regard shall be final and binding upon the Submitter/Participant, and the Submitter/Participant shall not at any time challenge and/or dispute such decision of the Company.

9. **Miscellaneous.** You agree to be bound by these Terms and by the decisions of the Company, which are final and binding in all respects. The Company reserves the right to change these Terms and/or the Privacy Policy at any time, at its sole discretion. It is the sole responsibility of the Submitters to keep themselves updated from time to time with all the details and/or updates of the Program and these Terms. Additionally, the Company has the right to suspend or cancel the Program or any participation of the Participant in the Program at its sole discretion. Submitters who violate the Terms, interfere in the production of the Program or harass any person of any gender (in a sexual or other manner) or engage in any conduct that is detrimental, or unfair to the Company, the Program or any other persons (in each case as determined in the Company sole and absolute discretion) are subject to immediate disqualification. The Company reserves the right to exclude individuals whose eligibility is in question or who have been disqualified or are otherwise ineligible to participate in the Program.

10. Other General Terms:

- a) You agree and confirm that the Company and the Production House shall at no time be held responsible and/or liable for any non-receipt of an Entry or if you are prevented from submission of a successful Entry due to a technical error and/or defect in the functioning of the website server, network problem, breakdown of machinery, unclear network, disruption in the network, technical malfunctions, network crashes, server failures, or lost/distorted electronic data submissions including any such concerns or issues with that of the third party service provider/s as engaged by the Company or the Production House and to the extent permissible in law, you waive your right to initiate any claim, proceedings, actions, damages, suits, in relation to the same against the Company, the Production House and/or their affiliates. **For the purposes of the Terms, 'receipt' of an Entry occurs when the website server records the Entry information upon submission of the same by the Submitter. Any automated receipt confirmation does not constitute proof of actual receipt.**
- b) The Submitter shall be solely responsible for the data charges as charged by the Submitter's internet/telecom operator required for the submission of the Entry. In case of using internet/data while roaming in different circle/zone, additional roaming rates may apply. The Company and Production House shall not be responsible for any such charges incurred.
- c) You acknowledge and agree that You may be required to make yourself available for the Company and/or the Production House and participate in any activity and/or campaign of any nature whatsoever without any money payable to you.
- d) You hereby agree, represent and undertake to sign/execute, accept additional documents i.e. release letters, company policies etc., and produce further documents, as may be required by the Company and/or the Production House promptly, as and when called upon, in relation to your participation in the Program. The Company reserves the right to reject the entry and disqualify your participation in case of non-submission and/or delayed submission of such additional documents.
- e) The Company reserves the absolute right to immediately disqualify any Submitter/Participant and remove their data if they are found to be engaging in deceptive behavior, hacking, spamming, using destructive code, or violating these Terms. It is clarified that only those Submitters who fulfill all the requirements set out in these Terms, shall be considered for participation in the Program.
- f) The Company shall not be responsible to pay for any cost, expenses, applicable taxes, duties, charges, license fees, insurance and/or levies applicable under the laws of India, in relation to your participation in the Program. You hereby agree that any such amount stated above, including all income taxes, withholding taxes shall be solely borne by you.
- g) Only the explicitly confirmed and selected Participant whose name matches the Production House's records will be granted entry to the Program sets. The selected Participants are strictly prohibited from bringing friends, family members, colleagues or companions.
- h) Limitation of liability: By submitting the Entry, you acknowledge and agree that any and all disputes, claims and causes of action arising out of or in connection with your accessing of the Portal, the submission of your Entry, the determination of your participation in the Program or your actual participation in the Program shall be resolved individually, without resort to any form of class action. Notwithstanding the foregoing, under no circumstances will the Company, the Production House and/or their licensors and their respective affiliates be liable for any consequential, indirect, special, punitive, or incidental damages, lost business, lost goodwill or lost profits, whether direct or indirect, arising in any way whether in contract, tort (including negligence) or

otherwise. Without prejudice to the foregoing, in any case each of the Company's and the Production House's entire liability under these Terms shall not exceed the total monetary value of Indian Rupees One Hundred.

- i) Notwithstanding anything contained herein, you expressly agree that you shall not seek to enjoin or restrain the production, exhibition, distribution, licensing, advertising and/or promotion of any of the Company's or the Production House's programming, promotional or marketing material and/or any other rights including but not limited to intellectual property rights or content in this connection thereto. You hereby agree and understand that in the event of a breach and/or a threatened breach of the Terms, the Company and the Production House shall be entitled to any and all remedies in law and/or equity.
 - j) You hereby acknowledge that there does not now exist, nor has there ever existed, a fiduciary relationship, or a relationship in the nature of an agent and principal between you and the Company or the Production House. You further acknowledge that mere submission of the Entry shall not result in the establishment of a fiduciary relationship, or a relationship in the nature of an agent and principal between you and the Company or the Production House or does not promise any form of employment, engagement, or contract with the Company or the Production House.
 - k) Participation in the Program sets is entirely at your own risk. The Company and the Production House disclaim all liability for any personal injury, accidents, illness, or loss/damage to personal property sustained by the Participant while traveling to, participating in, or leaving from the Program.
 - l) You hereby acknowledge that in case any portion/clause of these Terms is deemed invalid or becomes unenforceable or prohibited by the law of the country, such portion/clause shall be considered divisible and shall not be taken into consideration, and the remainder of these Terms shall be valid and binding and of like effect as though such provision was not included herein.
 - m) You hereby irrevocably agree to maintain confidentiality in respect of any response and/or official communication that is sent to/shared with you from an employee or representative at the Company and/or the Production House in connection with your Entry, and/or the Program; and agree to make no public press announcements, social media post(s) or information for publication without the explicit approval of the Company.
 - n) You hereby acknowledge that your representations, warranties, indemnities and obligations as well as the confidentiality provisions and dispute resolution mechanism shall survive the efflux of time and the termination of these Terms.
 - o) The provisions of these Terms (including all the revisions and additions thereto from time to time) constitute the entire understanding and agreement between the Submitter/ Participant and the Company and the Production House in this connection, and supersede all prior understandings, if any, whether written or oral, in this connection.
11. **Governing Law and Dispute Resolution:** These Terms (and any dispute, difference, proceedings or claim of whatever nature arising out of or in connection with these Terms) shall be governed by, and construed in accordance with, the laws of India and shall be subject to the exclusive jurisdiction of the courts of Mumbai.
