

BIGG BOSS TELUGU - SEASON 10

VOTING TERMS AND CONDITIONS

These Terms and Conditions (*defined below*) shall be binding on each Viewer (*defined below*), in the territory of India ("**Territory**") who voluntarily desires to participate in the Voting Mechanism (*as defined hereunder*) of the Program, for the Shortlisted Participants (*as defined below*) competing in the program titled "**Bigg Boss- Telugu -Season - 10 ("Program") which is to be exploited on "Star Maa"** (hereinafter referred to as "**Channel**"), being the channel owned and operated by JioStar India Private Limited (*formerly known as Star India Private Limited*) ("**JioStar/Company**") and also on audio-visual streaming platform currently branded as "JioHotstar" (hereinafter referred to as "**Platform**") being the platform owned and operated by JIOSTAR and accessible from the Device(s) (*as defined below*).

The following voting terms and conditions ("**Terms and Conditions / Voting Rules**") govern the entire process of Voting Mechanism as detailed herein for participation in the Voting Mechanism and shall be binding on each Viewer. "**Viewer**" shall mean a participant in the Voting Mechanism, who resides in India, is a citizen of India, is physically present and located in India, and who has completed 18 years of age or above as on September 7, 2026.

For the purposes of this Terms and Conditions Device(s) shall mean smartphones running the Android (with version 4.4 and above)/ iOS (with version 10 and above) operating platforms, capable of receiving and transmitting data including via Internet and/or mobile communications technology and/or any other similar technology. The Voting may work on SIM (Subscriber Identification Module)-based devices other than smartphones operating on the Android (version 4.4 and above) or iOS (version 10 and above) operating platforms. However, we recommend that you participate in the Voting on smartphones for a better user experience.

The Terms and Conditions of and in relation to the Voting Mechanism as stated herein, are an electronic record in terms of Information Technology Act, 2000 ("Act") and rules thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008. This electronic record is generated by a computer system and does not require any physical or digital signatures.

Employees of JioStar, its associates, affiliates and JioStar's service provider for this Voting, are ineligible to claim any benefit pursuant to the Voting or any other Voting run by JioStar during the Voting Cycle.

These Terms and Conditions are irrevocably binding on each Viewer who voluntarily participates in the Voting Mechanism. The Viewer also agrees that the Platform's Terms of Use available at <https://www.hotstar.com/tnc/in> and Channel's Terms of Use available at ("**Terms of Use**") shall apply in relation to his/her registration, participation and/or use of the Platform and the Channel. The privacy policy available at <https://www.hotstar.com/privacy-policy/in> ("**Privacy Policy**"), shall be deemed accepted and agreed to by every Viewer, by agreeing to participate in the Voting Mechanism, shall govern all usage of any Personal Information (as defined in the Privacy Policy available at the aforementioned links) and/or any other information as detailed in the Privacy Policy and including but not limited to the mobile phone number and/or any information gathered by JIOSTAR under or pursuant to the Voting Mechanism. JIOSTAR will have access to and collect information and data shared by the Viewer including the Viewer's personal information such as email address, mobile number and/or any information in relation to the participation of the Viewer(s) in the Voting Mechanism gathered under or pursuant to this voting process by JIOSTAR (if any) ("**Data**"). By voting, the Viewer(s) consents to the collection, receipt, storage, processing, disclosure, transfer, use, retention and sharing of the Data by JIOSTAR, its affiliates and designated third parties in accordance with the terms of Privacy Policy. JioStar recommends that the Viewers maintain the privacy of your personal details and do not share their phone number, or any other personal details associated with the Platform on any other social media platform or any other website.

The Voting Mechanism shall be governed by the Principal Rules and General Rules as stated herein below and by agreeing to participate in the Voting Mechanism, Viewers shall be deemed to have unconditionally accepted and agreed to comply with and abide by the same prior to participating in the Voting Mechanism. If the Viewer does not agree to be bound or cannot comply with any of these Terms and Conditions and/or the Policies (defined below), then the Viewer should refrain from continuing with and/or participating in the Voting Mechanism. The act of voting and/or participating in the Voting Mechanism as detailed below shall be deemed to be the Viewer's absolute agreement to the Terms and Conditions contained herein, Terms of Use and Privacy Policy of the Platform and JIOSTAR (collectively, "Policies") as prescribed from time to time. These Terms and Conditions are made available at <https://help.hotstar.com/in/en/support/home> ("Website") These Policies may be amended by JIOSTAR at any time without prior notice to the Viewer.

These Terms and Conditions, contained herein shall subsist until the first telecast of the last episode of the Program and /or any such extended duration as may be deemed fit by JIOSTAR and hence, save and except terms that are indented to survive these Terms and Conditions, all other terms of these Terms and Conditions shall continue to apply to all Viewers in relation to any participation in the Voting Mechanism, till such time.

PRINCIPAL RULES:

The following are the Principal Rules for Voting Mechanism for the Program on the Channel and on the Platform, as conducted by JIOSTAR:

1. The Program is a reality show where individuals/housemates ("**Participants**") staying in the Bigg Boss House will nominate housemates for eviction from the Program at intervals decided by JIOSTAR ("**Shortlisted Participant**"). During the Program, the Viewers will be asked to cast their vote for the Shortlisted Participant whom they want to save from being evicted from the Program. The Viewer shall cast multiple votes (subject to maximum votes allowed per Voting Mechanism as detailed below) for different Shortlisted Participants. The Shortlisted Participant who gains the minimum votes from the Viewers, will be eliminated from the Program.
2. Further, JIOSTAR and/or the Channel shall be entitled to, at its discretion at any time during the telecast of the Program to re-introduce the eliminated Participant(s) or introduce fresh individuals/participants to participate in the Program ("**Wild Card Entries**").
3. In the event any of the Participants are unable to participate and/or unable to appear and/or withdraw their participation, for any reasons whatsoever, JIOSTAR and/or the Channel reserve the right to replace such Participant(s) with previously eliminated participants or replace such housemate with any other new participants and such decision shall be final and binding on all the Viewer(s). JIOSTAR and/or the Channel shall not entertain any complaints or queries related to it.
4. The Voting Mechanism (as detailed in clause 8 of Principal Rules) will open and end for the period tabulated in clause 11 below of Principal Rules ("**Period**") in the Territory as mentioned herein. During the Period, the Viewers in the Territory can vote for their favorite Shortlisted Participant, as per the Voting Mechanism detailed below. JIOSTAR and/or the Channel shall in its discretion be entitled to close the Voting Mechanism for specified Voting Cycles (*defined below*) during the Period. JIOSTAR may at any time, in its discretion, increase or decrease the Period for voting without any prior notice and liability whatsoever.
5. The Program will be published on the Platform from September 6, 2026 onwards and will be telecasted on the Channel at the timings stated below or such other dates and timings as required by JIOSTAR from time to time. It shall be each Viewer's sole responsibility to periodically check for any update(s) or modification(s) to the timings and dates for telecast of the Program, and periodically check the Website for other changes to the Voting Mechanism and/or other details pertaining to the voting.

6. The votes, for each episode/day ("**Episode/Day**"), should be sent only during the timelines specified hereunder and any votes sent after the Voting Cycle (*as set out below*) for the applicable Episode, shall not be considered and shall be deemed null and void.
7. To participate in the voting, the Viewers must watch/are deemed to have watched the Episodes of the Program being telecast on the Platform and/or Channel every day. The Viewers by participating in the Voting Mechanism will get an opportunity to cast their votes for any Shortlisted Participant of that Episode(s) of the Program.
8. The Viewers interested in voting can participate by choosing to cast their votes for their favorite Participant through any or both of the 2 (two) mechanisms as mentioned below and shall be subject to the respective mechanism's requirements and rules:
 - 8.1 **Missed Call Mechanism:** By dialing the numbers assigned to each Participant (*more fully given under*) from the Viewer's mobile phone / landline and casting the vote as more fully detailed in clause 9 of Principal Rules;
 - 8.2 **JioHotstar Mechanism:** Login to JioHotstar application in Android/IOS devices, visit the Bigg Boss Telugu page and click on the Vote now button as more fully described in clause 10 of Principal Rules;

All the above mechanisms together with any other mechanism that the Channel/JIOSTAR may provide from time to time shall hereinafter collectively be referred to as "**Voting Mechanism**". It is clarified that JIOSTAR can amend or modify or dismiss any of the above-mentioned mechanisms at its sole discretion.

9. **Missed Call Mechanism**

The Missed Call Mechanism for the Territory is as provided below:

- 9.1. The Viewer should use a valid Indian phone number, registered with network operators in the Territory.
- 9.2. To vote, the Viewers shall through their landlines/mobile numbers dial the unique number of the Shortlisted Participant for the particular Voting Cycle for whom they want to vote and give them a missed call. The unique number for the Participants shall be as follows:

9.3. It is clarified that each Viewer can cast only 1 (one) vote per day, per device for the corresponding Voting Cycle (defined below) throughout the Period by way of a missed call for the Shortlisted Participant from a landline and/or mobile number that is registered with a network operator within the Territory. The Viewer will receive an SMS/response from JIOSTAR for the first vote only (if voting is done through mobile only) for the applicable Voting Cycle.

9.4. The Viewer will not be charged by JIOSTAR in the Missed Call Mechanism to cast the votes.

10. **JioHotstar Voting Mechanism:**

A Viewer interested to cast his/her vote, by using JioHotstar Voting Mechanism, will be subject to the following mechanism:

10.1. JioHotstar Voting Mechanism shall only be available on the Platform through the 'Jio Hotstar' on Android and iOS devices ("**App**") and not on or through the website.

10.2. The Viewer will have to download the App (if not already available on the device), login to their account on the updated App, visit the 'Bigg Boss Telugu' page and click on the Vote now button for casting his/her vote through this Voting Mechanism. Viewers are advised to check for updates of the App from time-to-time. Viewers shall be using their login IDs for registering on the Platform at their own risk. Any failure or usage of domain page by any unauthorized party will not be considered by JIOSTAR to allow a Viewer to vote again or withdraw any vote and JIOSTAR shall not entertain any queries in this regard.

10.3. The Bigg Boss Telugu page will list the names of the Shortlisted Participant in a particular Voting Cycle.

10.4. The Viewer has to cast his/her vote for their desired Shortlisted Participant's against his/her name/emoji to save him/her from eviction.

10.5. Upon completion of the voting, the Viewer may click on done to close the voting page/sheet on the App.

10.6. In case of any technical issue because of which JIOSTAR in its sole discretion is of the view that there is an unfair advantage/disadvantage to any one or more Shortlisted Participants, or in case of any technical issues due to which the votes that have been captured are incomplete or unavailable, JIOSTAR shall decide on the course of action in the interest of the Program (including capping of votes based on other parameters) and proceed. No questions shall be entertained in this regard by JIOSTAR.

10.7. Only 1 (one) vote per day per device, per corresponding Voting Cycle will be allowed through the Viewer's Android and /or IOS Device and/or any operational devices for a particular Shortlisted Participant. In the event if a Viewer participates in the Voting from different profiles during the different Voting Cycle, (a) the name used in the profile through which the Viewer participates for the first time on a Voting Cycle will be taken into consideration by JioStar on that Voting Cycle; and (b) the name used in the main profile associated with the user account will be taken into consideration by JioStar for the entire Period.

- 10.8. The Viewer will not be charged in JioHotstar Voting Mechanism to cast the vote, however, there may be cost levied to the Viewer, at the applicable rate, by the network provider for using internet connection which should be verified by the Viewer at his/her sole responsibility. In case of casting vote while roaming in different circle/zone, additional roaming rates for browsing of the internet may be applicable. JIOSTAR, Channel or the Platform shall not be responsible for any such charges incurred by the Viewer and all charges for browsing/using internet to cast such vote shall be borne solely by the Viewer.
11. In the Voting Mechanism, the Viewer should cast his/her votes for a particular Shortlisted Participant, for the respective Episodes of the Program, during a particular Voting Cycle (as defined below) and any vote cast after the Voting Cycle shall neither be considered as vote(s) for that Episode nor for the next Voting Cycle. The voting cycle for each Episode shall commence from the Start time and end on the voting End Time ("**Voting Cycle**") as detailed below, on the start date as mentioned on the Channel:

NOTE: Only 1 (one) vote will be allowed per day per Mobile/Landline, per Voting Cycle.

Only 1 (one) vote will be allowed per day per login, per Voting Cycle. The Viewers may cast the vote allowable per day to any one of the participants of their choice. Any number of votes cast including during the Voting Cycle, exceeding the limit mentioned hereinabove, will not be valid and shall be rendered null and void.

12. Votes sent after the Period and/or after the applicable Voting Cycle as tabulated in clause 11 of Principal Rules, will not be considered valid and shall be deemed null and void without requirement of any further intimation by JIOSTAR or the Channel. JIOSTAR/Channel reserves the right to alter/modify/ reduce or increase the duration of the Voting Cycle as and when it desires without any further liability or notice to any person.
13. Every week, the Shortlisted Participant with the lowest number of votes will get eliminated from the Program and other remaining Participants will be eligible to continue in the house, in accordance with the format of the Program. It is further clarified that the elimination is purely based on the cumulative of votes received through the Voting Mechanism, as set out herein. In no event, shall the Participants, the Shortlisted Participants, or the Viewer(s) dispute the decision made by JIOSTAR and/or the Channel or make any claims in this respect in regard to any aspect of the Program and/or the Voting Mechanism including the Terms and Conditions, the format of the Program, selection of the Shortlisted Participants, the Shortlisted Participant being evicted on the basis of the votes received, or any remaining Participants surviving the elimination.
14. JIOSTAR and/or the Channel reserve the right to modify the format of the Program, timelines mentioned above and accordingly the rules for Voting Mechanism at any time, at its discretion, during the telecast of the Program or at any time during the Period. It shall be the sole responsibility of the Viewer(s) to read the Voting Rules from time to time available on the Website. It is further clarified that in case of final scores (*i.e.*, votes received as per the Voting Mechanism) being tied for two (2) or more Participant(s), the decision of JIOSTAR and/or the Channel shall be final and binding on the Viewer(s)

and the same shall not be disputed and/or challenged in a court of law, to the extent permissible under law. Without limiting the foregoing, under no circumstances will JIOSTAR, Channel, its assigns and/or affiliates be liable for any consequential, indirect, special, punitive, or incidental damages or lost profits, arising in any way whether in contract, tort (including negligence) or otherwise. The Viewer specifically waives his/her right to seek injunctive relief against JIOSTAR, the Channel, its assigns and/or any of their affiliates or any entity in relation to the Program, and/or the Voting Mechanism, to the maximum extent permitted by law;

15. The details of the Voting Mechanism will be announced during the telecast of the Program on the Channel.
16. The Viewer(s) can cast their votes for only those Shortlisted Participant(s) of the Program who have participated in that particular Day/Episode. Any votes sent by the Viewers for the Shortlisted Participants who were not a part of that particular Day/Episode due to elimination or not shortlisted for any other reason whatsoever, shall not be considered valid and shall be null and void. Further, any votes cast before or after the Voting Cycle mentioned in the 'Voting Mechanism' shall not be considered valid and will not be counted.
17. The voting is merely to enable the Viewers to choose their favorite Participant or to vote for the performance of a particular Shortlisted Participant that they have liked. No winners will be declared and/or prizes distributed for the Viewers participating in the Voting Mechanism. Each Viewer participating in the Voting Mechanism agrees and acknowledges that he/she shall not be entitled to any gratification of any nature whatsoever. Viewers shall not be entitled to make any claims in respect of any compensation or gratification whether monetary or otherwise against the Channel, JIOSTAR and/or the Program or entity in relation thereto.
18. The elimination of the Shortlisted Participant by the Voting Mechanism and/or the decisions made by JIOSTAR and/or the Channel in any aspect of the Program/Voting Mechanism shall be final and binding on all the Viewers and in no event, shall the Viewers dispute the decision made by JIOSTAR, Channel and/or its employees/representatives in connection to the same.

GENERAL RULES

1. Availability for JioHotstar Voting Mechanism:

- a. The Voting is available only in the English language and in the portrait mode of JioHotstar Application. The Voting can be best experienced when the App notifications have been turned on.
- b. Other than the Device(s), the Voting Cycle will not be accessible through web browsers, and any third-party live TV streaming medium or any other operating systems/platforms on which the App is available.

2. Intellectual property:

- a. Viewer shall not have any ownership interest, license or other rights in the application for the Voting and/or the Program or any right in the Voting intellectual property and/or the Program intellectual property therein, whether by license (except as provided in sub-section below), implication, estoppel or otherwise.
- b. The Intellectual Property rights ("**Intellectual Property Rights**") in the App, Platform and JioStar and material published on the App, including (but not limited to) the Program, Voting, software, advertisements, written content, photographs, graphics, images, illustrations, marks, logos, audio or video clippings and flash animation, is owned by JioStar, its licensors and/or its affiliates and associates. Viewer may not modify, publish, transmit, participate in the transfer or sale of, reproduce, create derivative works of, distribute, publicly perform, publicly display, or in any way exploit any of the materials or content on JioStar either in whole or in part without express written license from JioStar.

3. The Viewer shall not, without the prior written approval of JioStar, speak to the press or any other media or any third person, nor give any interviews or comments relating to any aspect of the Voting and/or the Program.

4. You shall not disclose any information whatsoever relating to Jiostar to any other party including screen shots of the Voting and/or photos of the Program or your experience at the Program on social media websites unless permitted by Jiostar.
5. The Voting and any aspect(s) thereof will be made available on the App as per the discretion of Jiostar.
6. Jiostar, at its own discretion may choose to run other forms of contests, bumper rounds, games hosted by Jiostar or get third-party sponsors and partners during the course of the Voting.
7. Violation of any provision of these Terms and Conditions and/or any applicable laws may lead Jiostar to immediately restrict your access to the App or any part thereof (including the Voting).
8. Jiostar, at its own discretion, may choose to display sponsor advertisements during the Voting which shall be visible on App.
9. The Viewer by way of voluntarily participating in the Voting, represents and warrants that he/she has read these Terms and Conditions and that he/she is 18 years old or above. The Viewer further represents and warrants that (i) he/she is not restricted from or under any disability, whether legal, contractual or otherwise which may restrain/prevent him/her from participating in the Voting Mechanism; and (ii) he/she shall comply with the applicable laws and these Terms and Conditions and the Policies. Failure of any Viewer to comply with the Terms and Conditions and/or the Policies will disqualify such Viewer from participating in the Voting Mechanism and/or render the vote cast by such Viewer null and void.
10. Proof of age, if requested, of the Viewer(s) must be submitted to JIOSTAR as may be required by JIOSTAR to confirm the eligibility of the Viewer(s).
11. JIOSTAR and/or the Channel reserves all rights to make amendments to the existing Terms and Conditions, and/or withdraw, change, alter, amend the Voting Mechanism, process of elimination including any Shortlisted Participants for a Voting Cycle, the schedule of the Episodes of the Program and/or, Participants of the Program and/or any other details of the Program, Terms and Conditions, Period and/or Program etc., at any time, without any prior notice to the Viewer. It is deemed by agreeing to participate in the voting, the Viewer has verified the Terms and Conditions on JIOSTAR's Official website at <https://www.jiostar.com/legal-terms-policies/> agreed to the Terms of Use.
12. JIOSTAR reserves the right to cancel, reschedule, and/or postpone the Program and/or the Voting Mechanism for any or all Episodes without assigning any reasons and/or without giving any prior intimation or liability to the Viewers or any other person.
13. All viewer(s) are advised to remain in areas with strong and stable/continuous mobile network signal of the telecom operator to ensure smooth functioning of casting of vote.
14. Existing Appl Users may have to upgrade their App to the latest version from the App Store (iOS) or Google Play (Android) to participate. New users can access the Voting by downloading the App from the App Store (iOS) or Google Play (Android). We urge you to install all App updates that are released from time to time to enjoy the latest features on the Voting.
15. You are advised to keep adequate RAM and phone memory available to ensure smooth functioning of the Voting. Quitting other applications on the Device will also help towards smoother Voting functioning in case of some smartphones.
16. You may need to adjust the Device display, font, brightness and resolution to default size or lower to ensure that you are able to respond to the Voting on your Device(s) properly.
17. Viewer(s) agree and acknowledge that there is no prize/gratification in voting for the Shortlisted Participant as detailed herein. Viewers shall not be entitled to make any claims in respect of any

compensation or gratification whether monetary or otherwise, against the Channel, JIOSTAR and/or the Program.

18. The Voting Rules shall be advertised sufficiently across the Website and /or the Channel to ensure that no Viewer is misled and each Viewer fully understands the entire process and costs (if applicable) for voting. It is clarified that all costs towards voting shall be borne by the Viewer solely without any recourse whatsoever to JIOSTAR and/or the Channel.
19. In case a Viewer(s) is found to be in non-conformance of the Voting Rules, then JIOSTAR will be entitled to at its sole discretion disqualify the Vote(s) received from that Viewer(s). Such decision shall be final and binding on the Viewer(s) and to the extent permissible by law, the same shall not be disputed or challenged.
20. Neither JIOSTAR nor the Channel or any of its affiliates including the Platform, licensors, licensees, assignors and assignees shall be responsible in any manner whatsoever for any acts or omission of any third party service providers including any network problems, technical failures, interruptions, disruptions, malfunction, system failure whatsoever and/or the data charges/costs charged by the network operator(s) and/or any other problems which may occur due to the failure of the Voting Mechanism or misuse of the Voting Mechanism or any kind of problems in connection thereto. Any dispute in connection to the same should be settled between the Viewers/subscribers and the operator(s) directly without involving JIOSTAR and/or the Channel in any manner. Notwithstanding anything to the contrary, JIOSTAR and/or the Channel and/or Platform shall in no manner be responsible for the inability, failure of the Viewer to cast any vote or delay in casting of any vote, for any reasons whatsoever, including without limitation network failure, technological reasons or any events beyond JIOSTAR's/Channel's/Platform's control. Viewers shall not in any circumstances make any claims and, to the maximum extent permissible under law, hereby irrevocably and perpetually waive their right to make any claim against JIOSTAR, Channel, Platform, their employees, directors and its affiliates arising out of or relating to any and all costs, injuries, losses or damages of any kind, including, without limitation due to any technical faults in the network and /or connections or directly or indirectly due to, to their participation or non-participation in the Voting Mechanism/Program;
21. Neither JIOSTAR nor the Channel or any of its affiliates including the Platform shall be responsible for any unauthorized access to any data of any person including any Viewer and/or for any compromise on private / confidential user related, or any other data, including but not limiting to user ids, email address, names, and any other personally identifiable details of the Viewers.
22. Without limiting the provisions of clause 3 of these General Terms, in case of any network failure, technical problem and/or for any reasons whatsoever, JIOSTAR reserves the right to change the Voting Mechanism or any aspect thereof, and/or cease from accepting votes of the Viewers for any and/or all the Episode(s)/Voting Cycle(s) of the Program or take such necessary steps as it may deem fit.
23. While all attempts will be made to protect the voting data from loss and/or corruption, Viewers agree and acknowledge that all systems are prone to failure and/or hacking attempts. In the event of any data loss, JIOSTAR may disqualify all the votes received or conduct a re-voting or continue with whatever data available in the manner it deems fit, at its sole discretion without any intimation or liability to any person whatsoever. JIOSTAR will not be responsible for any damage resulting from the loss of votes/data or action taken by JIOSTAR on account of the same. JIOSTAR will not be responsible to make good any loss or dissatisfaction suffered by the Viewer on account of such loss.
